**RE:** Video Gaming Fee Comparison

The City of Peoria regulates and licenses video gaming establishments and video gaming terminal operators. The City charges two separate fees. First, there is a \$500.00 per terminal licensing fee which is split evenly between establishments and operators. Secondly, there is a specific operator's license fee in an amount of \$1,000.00 per terminal. Establishments must pay a total of \$250.00 per terminal and operators must pay a total of \$1,250.00 per terminal.

In December 2021, the Illinois legislature passed a new law requiring establishments and operators to share all video gaming fees equally. 230 ILCS 40/65 states, in relevant part, "The cost of any fee imposed under this [Video Gaming] Act by any home rule unit of government or non-home rule unit of government shall be *shared equally* between the terminal operator and the applicable licensed establishment..." (emphasis added). The City is not compliant with the new law as it currently charges operators an additional \$1,000.00 per terminal.

The following is a comparison of other Illinois municipalities' video gaming license fees:
