## **ORDINANCE 17,488**

## AN ORDINANCE AMENDING THE CITY OF PEORIA 2017 AMENDED ANNUAL BUDGET RELATING TO THE CDBG FUND AND CAPITAL FUND TO REALLOCATE CDBG PROGRAM INCOME TO THE CAPITAL FUND IN THE AMOUNT OF \$4,075.00.
