AN ORDINANCE AMENDING THE CITY OF PEORIA BUDGET FOR FISCAL YEAR 2014 RELATING TO THE 2014 CDBG, HOME AND ESG BUDGETS TO REFLECT THE ACTUAL 2014 ALLOCATION FROM THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND THE TRANSFER OF PROGRAM INCOME TO THE CAPITAL FUND
