## **ORDINANCE NO. 17,952**

# AN ORDINANCE AMENDING APPENDIX A THE UNIFIED DEVELOPMENT CODE OF THE CITY OF PEORIA RELATING TO MANUFACTURED/MODULAR BUILDING SALES

**WHEREAS**, the City of Peoria is a home rule municipality pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, as a home rule municipality, the City may exercise any power and perform any function pertaining to its government and affairs including zoning regulations and uses; and

WHEREAS, the City of Peoria desires to amend Appendix A, the Unified Development Code;

NOW, AND THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS AS FOLLOWS:

<u>Section 1:</u> Appendix A of the Peoria City Code, being Ordinance No. 17,403 as adopted on October 11, 2016, is hereby amended by adding the following underlined words:

#### 5.3.3 Commercial Use Performance Standards

### N. Manufactured/Modular Building Sales Allowed by Special Use

The following performance standards shall apply:

- Where this use is adjacent to any residential district, there shall be a 100 percent opaque eight-foot high visual barrier or screen on the property line abutting the residential zoning lot, provided such barrier or screen shall not restrict clear sight at any intersection or driveway. A planted transitional buffer yard in accordance with Section 8.2.9 is also allowed.
- Building display area must be depicted on a site plan subject to Development Review Board approval.

- 3. All buildings and structures in the display area must be marked for sale, situated in an orderly manner and be placed on a hard surface.
- 4. Buildings displayed for sale cannot exceed 150 sq. ft. in size.
- 5. On-site staff is required during standard business hours.
