AN ORDINANCE LEVYING AND ASSESSING TAXES FOR THE FISCAL YEAR BEGINNING APRIL 1, 2015 AND ENDING MARCH 31, 2016, FOR THE GENERAL ASSISTANCE FUND OF THE TOWN OF THE CITY OF PEORIA, PEORIA COUNTY AND STATE OF ILLINOIS

BE IT ORDAINED BY THE BOARD OF TOWN TRUSTEES OF THE TOWN OF THE CITY OF PEORIA, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. That the total amount of appropriations for General Assistance purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of One Million Five Hundred Fifty Seven Thousand Five Hundred Twenty Seven Dollars and No/00 (\$1,557,527).

<u>SECTION 2.</u> That the sum of <u>One Million Five Hundred Fifty Seven Thousand Five Hundred Twenty Seven Dollars and No/00 (\$1,557,527)</u> being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Town of the City of Peoria for the purposes of providing for a General Assistance Fund, as appropriated for the current fiscal year by annual appropriation ordinance of the Town of the City of Peoria for the fiscal year 2015-2016 passed by the Board of Trustees of said Town at the legally convened meeting of April 14, 2015, be and the same is hereby levied upon all the taxable property in the Town of the City of Peoria subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "TO BE RAISED BY TAX LEVY" which appears over the same, the tax levied being for the current fiscal year of said Town, and for the said appropriation to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:
