**AN ORDINANCE AMENDING THE CITY OF PEORIA CAPITAL BUDGET FOR FISCAL YEAR 2014 TO RECOGNIZE THE RECEIPT OF TRUCK ACCESS ROUTE PROGRAM (TARP) FUNDS FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$40,500.00 FOR THE TOWNLINE ROAD CONSTRUCTION PROJECT AND THE CORRELATING INCREASE IN PROJECT EXPENSE**

WHEREAS, the City Council did adopt, on November 26, 2013, the Budget for Fiscal Year 2014 of the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2014 Budget should be amended in order to add certain expenditures that were not included in said 2014 Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

Section 1. The Budget for Fiscal Year 2014 of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:


