AN ORDINANCE AMENDING THE CITY OF PEORIA BUDGET FOR FISCAL YEAR 2015 RELATING TO THE 2015 CDBG, HOME AND ESG BUDGETS TO REFLECT THE ACTUAL 2015 ALLOCATION FROM THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AND THE REALLOCATION OF REMAINING FUNDS FROM COMPLETED PROJECTS AND THE ALLOCATION OF PROGRAM INCOME

WHEREAS, the City Council did adopt, on November 25, 2014, the Budget for Fiscal Year 2015 of the City of Peoria; and
