WHEREAS, the properties herein described are now zoned in a Class C-2 (Large Scale Commercial) District; and

WHEREAS, said Planning & Zoning Commission has been petitioned to amend an existing Special Use for a Shopping Center under the provisions of Section 2.15 of Appendix B, the Zoning Ordinance of the City of Peoria: and

WHEREAS said Planning & Zoning Commission held a public hearing on April 7, 2016, pursuant to a notice of the time and place thereof in a newspaper of general circulation in the City of Peoria, not less than fifteen (15) days nor more than thirty (30) days prior to said hearing as required by law; and

WHEREAS, said Planning & Zoning Commission has submitted its report of said hearing and the City Council finds that to permit such special use amendment will not adversely affect the character of the neighborhood, and will not unduly burden the public utility facilities in the neighborhood;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS, AS FOLLOWS:

Section 1. That an amendment to the existing Special Uses for a Shopping Center to remove 0.68 acres of property, currently owned by RLI, from its special use boundary and add to the adjacent special use boundary for Kroger and construct a 20,800 sq. ft. building addition to the Kroger grocery store and parking lot expansion is hereby approved for the following described property:

Said Ordinance is hereby approved per the submitted Site Plan (Attachment A), Landscape Plan (Attached B), and Elevation Drawings (Attachment C) and with the following conditions and waiver:

- 1) Provide a revised landscape plan which includes additional parking lot peninsulas, landscaped with trees, along the east property line.
- 2) Replace non-ADA-compliant curb ramps at the north and south entrances on Lindbergh Dr. Sidewalk cross slope through drive approaches shall be no steeper than 2%.
- 3) Special event and/or sales located in the parking lot or private building sidewalk may occur provided that any tents or other temporary covered structures and any temporary signage shall comply with all Codes of the City of Peoria.
- 4) Waiver to reduce the required front yard setback from 20 feet to 10 feet.
- 5) Waiver to allow banners on all light standards in the parking lot. Size of banners must comply with current zoning regulations.

<u>Section 2.</u> All provisions of Appendix B, the Zoning Ordinance of the City of Peoria, with respect to the Class C-2 (Large Scale Commercial) District shall remain applicable to the above-described premises, with exception to amended Special Use herein permitted.






