

**AN ORDINANCE PROPOSING THE CREATION OF A  
PEORIA SPORTS CENTER HOTEL TAX  
SPECIAL SERVICE AREA IN THE CITY OF PEORIA, ILLINOIS,  
AND PROVIDING FOR A PUBLIC HEARING AND  
OTHER PROCEDURES IN CONNECTION THEREWITH**

**WHEREAS**, The City of Peoria is home rule unit exercising power and authority pursuant to Section 6 of Article VII of the Illinois Constitution of 1970; and

**WHEREAS**, The City of Peoria desires to establish, by virtue of its home rule powers and the Illinois Special Service Area Tax Law (35 ILCS 200/27-5 et seq.) a Special Service Area within the City of Peoria; and

**WHEREAS**, the City of Peoria has received a request from an owner of land within the proposed Special Service Area asking that a Special Service Area be established:

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Peoria, Illinois as follows:

**Section 1. AUTHORITY TO ESTABLISH A SPECIAL SERVICE AREA**

The authority to establish and finance a Special Service Area is provided in Section 6(l) of Article VII of the Illinois Constitution of 1970, which provides, in pertinent part:

The General Assembly may not deny or limit the power of home rule units ... (2) to levy or impose additional taxes upon areas within their boundaries in the manner provided by law for the provision of special services to those areas and for the payment of debt incurred in order to provide those special services.

and by the Special Service Area Tax Law (35 ILCS 200/27-5 et seq.).

**Section 2. FINDINGS**

The City Council of the City of Peoria, Illinois finds:

- (a) That the consideration, by public hearing, of the extension and continuation of an area hereinafter described in Section 3 as a Special Service Area for the services and purposes therein set forth is in the public interest.
- (b) That said area is a contiguous area within the City of Peoria.
- (c) That the services for which provisions are made, as set forth, are in addition to those governmental services generally provided by the City of Peoria throughout said municipality.
- (d) That the establishment of the Peoria Sports Center Hotel Tax Special Service Area will provide services to businesses within the boundaries of

the Special Service Area over and above those typically provided pertaining to government affairs of the City of Peoria; such services to include:

1. Initial construction of an athletic campus and sports complex within the boundaries of the Special Service Area.
  2. Maintenance, repair, or replacement of any capital improvement upon the athletic campus.
- (e) That it is in the best interests of the property owners within the Special Service Area that an additional hotel tax be imposed against the properties in said Special Service Area for the aforementioned purposes.
- (f) That it is in the best interests of the property owners within the Special Service Area that bonds be issued as a general obligation (and with the full faith and credit) of the City.

Section 3. PUBLIC HEARING – TAX RATE – ISSUANCE OF BONDS

A public hearing is hereby scheduled for the 22nd day of April, 2014 at 6:15 p.m., or as soon thereafter as the matter may be heard, in the City Council Chambers, Room 400, City Hall, Peoria, Illinois, to consider:

- (a) The creation of a Special Service Area within the City of Peoria on the property depicted on the attached map (Exhibit A), and labeled as the “Peoria Sports Center Special Service Area” for the purpose of establishing funds for the construction of an athletic campus and sports complex within the Special Service Area, and for maintenance, repair, or replacement of any capital improvement thereof.
- (b) The imposition of an additional hotel tax upon properties within the Special Service Area, proceeds of which will be used to repay the debt service issued to fund the construction of an athletic campus and sports complex within the Special Service Area and the maintenance, repair, or replacement of any capital improvement thereof.
- (c) The issuance of bonds or other debt obligations of the City with the repayment thereof being assured as a general obligation (and with the full faith and credit) of the City for the construction of an athletic campus and sports complex within the Special Service Area and the maintenance, repair, or replacement of any capital improvement thereof.

Section 4. NOTICE OF PUBLIC HEARING

Notice of the Public Hearing shall be published in the Peoria Journal Star not less than 15 nor more than 30 days prior to the date of hearing, in accordance with the requirements of 35 ILCS 200/27-25, 200/27-30, and 200/27-45.

Section 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect immediately upon its passage.
