





Dear Commissioners.

A site approval application has been received from *Al Kadi, Inc.*, d/b/a Rocky's Market, 1500 NE Jefferson Ave., Peoria, Illinois. Approval of this site application would allow the applicant to sell packaged liquor for off-site consumption at this location.

Officer Kevin Slavens inspected the site which sits on the corner of Jefferson Avenue and Caroline Street. The site is currently open and operating as a convenience store and holds tobacco licenses with the City of Peoria and State of Illinois. This location previously operated as Patch Me Custom Embroidery & Screen Printing and Boost Mobile since 2016.

The site is located in a residential neighborhood with several houses along both sides of the 1500 and 1400 blocks of NE Jefferson Avenue. Nearby residences to this site include: 1501, 1503, 1509, 1510, 1417 and 1416 NE Jefferson Avenue. All of these residences are approximately 95 feet to 185 feet from the proposed site. There is also a residence at 308 Caroline (apartments A & B) that is located immediately behind this site, approximately 40-45 feet from the rear of 1500 NE Jefferson Avenue and separated by a public alley way. Additionally, this proposed site is located approximately 3-5 blocks to the southeast from Peoria Public Schools - Lincoln Middle School and Woodruff Career & Technical Center. The close proximity of these two schools to the proposed site makes this a very unfavorable location for the sale of packaged liquor.

This site resides in the center of the North Valley / Averyville area of town and is located near three other liquor stores, four other convenience stores, two local taverns and one gas station. All of these businesses are located within a 1.1-mile radius from this proposed site. The Peoria Police Department does not believe there is an economic need, nor community desire for another liquor store in this area of town. The Peoria Police Department believes that the residents in this area of town (police districts 5 and 12) are well serviced for the sale of packaged liquor by In-N-Out Liquors, Tony's Market, Short Stop Food Market, Cole's Corner Tap and Veterans Pub & Pizza. Also included with this site letter is a map showing the geographical locations and mileage distances of these ten retailers from this proposed site.

From January 1, 2019 to December 31, 2020, the Peoria Police Department has responded to 34,539 police calls for service in these two North Valley districts alone. The Peoria Police Department feels that the addition of another liquor store in this specific area of town will only increase the already high call volume in the North Valley / Averyville area of town and further strain police resources. Historically, liquor stores have led to an increase in crime, traffic, noise, litter and other similar quality of life issues resulting in a general overall decline of a neighborhood.

Furthermore, the Peoria Police Department also has strong concerns that the addition of a convenience size grocery store that sells packaged liquor in a residential area would be detrimental to the surrounding two schools, nearby public housing, the numerous other retail businesses in this area of town and the neighborhood in general. Site approvals, being location specific and not owner specific, have proven extremely difficult to revoke once approved.

Finally, this site previously went before the City of Peoria, Liquor Commission under a different applicant in May 2016. That site approval application request (#16-08) was recommended for denial by the Peoria Police Department and also denied by the City of Peoria, Liquor Commission on May 2, 2016. Accordingly, the Peoria Police Department recommends **denial** of this site approval application.
