RE: Temporary Liquor License Application Build Peoria 1200 - 1300 blocks of SW Adams St. Class H (outdoor event)

Dear Mr. Ardis,

Enclosed is an application from *Build Peoria* for a Class H temporary liquor license. This license will be used on Saturday, October 12, 2019 in the 1200 – 1300 blocks of SW Adams Street. Build Peoria is hosting their 2<sup>ND</sup> annual *Big Picture 2019 Street Festival*. The license will be used from 10:00 a.m. to 6:00 p.m. and allow for the sale and on-site consumption of alcoholic beverages. This event will consist of children's art painting, family-fun activities, live music and food venders will be on-site.

Public Works will barricade this area along SW Adams Street from Spencer Street to MacArthur Highway. The music stage and beer tent will be located in the 1200 block of SW Adams at Spencer Street. Volunteers will be checking IDs and issuing wristbands in this designated area. Proceeds from this fundraiser will benefit Build Peoria, a registered not-for-profit organization with the Illinois Secretary of State.

Officer Kevin Slavens conducted a background check of the sole-officer listed on the application. Mr. Nicholas A. Yates is listed as the president and secretary of the organization. Ms. Eileen B. Leunig will be the event chairman. Nothing was found that would prevent these individuals or this organization from holding the requested temporary liquor license.

The Peoria Police Department has no objections to this temporary liquor license request.


