


Citywide Snow Routes

21 Routes in 2019






17 Routes in 2020



Winter Staffing

2019-2020 SEASON:

- 37 permanent maintenance employees*
- 22 temporary employees
- •59 total





- 32 permanent maintenance employees*
- 15 temporary employees
- 47 total





*On roster – does not include illness or injury absences



Snow Route Treatment

- PRIMARY ROUTED STREETS 158 miles
 - Pre-treatment (anti-icing)
 - Salt treatment (de-icing) breaks the bond or keeps snow/ice in a condition allowing snowpack to be plowed.
 - Plowing





Priority Snow Route System

2019-2020 SEASON:

- Previously 20 snow routes
- Route 21 created, 2019-2020
 - No additional employees or equipment to fleet
- (4) designated hill routes
- (8) tandem plow routes
- Two 12-hour shifts

PEORIA

When two or more inchesforecast

2020-2021 SEASON:

- Previously 21 snow routes
- Reduced to 17 routes, 2020-2021
- Fewer permanent maintenance and temporary employees
 - (2) designated hill routes
- (8) tandem plow routes
- Two 12-hour shifts
 - When two or more inches forecast



Residential Snow Routes

RESIDENTIAL STREETS - 321 miles

- Not salted except under extreme conditions
- Plowed only after completing primary streets
- No bare pavement policy on residential streets

ALLEYS - 80 miles

- Not salted
- Plowed at five inches of accumulation, only after primary and residential streets are completed
- Pass-through only



Removal and Timing

2020-2021 SEASON:


Between two and six inches:

 Removal within 36 hours after snowfall has ended


Six inches or more:


 Removal within 48 hours after snowfall has ended





A-B-C Routes








ABC Snow Routes Route₁A

Storm Event #2 = B-C-A

Storm Event #3 = C-A-B

Storm Event #4 = A-B-C 9



Parking Enforcement

EMERGENCY SNOW ROUTES

- Signs are posted on Emergency Snow Routes only
- No parking is automatically enforced when snow reaches two inches or more
- Remains in effect for 48 hours
- \$50 dollars (current fine)
 - \$75 after 7 days

PEORIA

- \$100 after 30 days
- Tickets can be reissued every 24 hours

Other Parking Bans

NO PARKING BAN (Citywide or Specified Area)

- City Manager or designee can order
- Remains in effect until terminated
- Notice for motorists to move vehicles will be well communicated, enforced by police, \$50 fine





Other Parking Bans

RESTRICTED PARKING BAN (Citywide or Specified Area)

- When warranted, city officials can prohibit parking from 9 a.m. to 9 a.m. the following day on certain days of month
 - o even-numbered addresses on even-numbered days
 - o odd-numbered addresses on odd-numbered days





Brine Application

- Brine Machine: produces liquid salt brine in-house
- Less 10 cents per gallon
- Efficient up to 20 degrees



- Calcium Chloride: most effective for applications lower than 20 degrees
- 2019-2020 Season: brine applicator used only on hills, overpasses and hazardous roadways as pretreatment
- 2020-2021 Season: to be used on all primary routed streets and residential streets deemed hazardous







Equipment

INDUSTRIAL SNOW BLOWER:

- Moves up to 1,800 tons per hour
- Can load a tractor trailer in less than 30 seconds
- Can reopen roads closed due to drifting
- Frequently used during Category 5 or Category 6 snowstorms







Commercial Sidewalk Snow Removal

- Commercial property owners are expected to comply with the ordinance
 - Including: businesses, schools, churches and hospitals
- Snow clearing should be a basic safety operation for customers, clients or patients
- Snow shall not be placed in the street or block fire hydrants or mailboxes
- Aiming to ensure City is safe and walkable



Commercial Sidewalk City Ordinance

SECTION26-25: all commercial property owners are required to remove snow from public sidewalks adjacent to their property





- Four foot wide path must be cleared within 24 hours for less than six inches and within 36 hours for more than six inches
- Noncompliance could result in a civil penalty:
 - \$50 for sidewalks less than 200'
 - \$100 for sidewalks more than 200
- Failure to comply may require City to remove snow/ice on private property
- Costs would be charged to owner

Future Considerations

- Recycling salt wash for brine
- Purchase additional wing plow for wider plowing using less manpower, equipment and fuel
- Purchase larger brine tank for greater coverage between re-loads

- Up-to-date storm recordings available at (309) 494-8830
- Public Access Channel 22 crawl
 - plowing and parking ban information
