

A site application has been received from *Crafted DIY Studio*, *LLC*, d/b/a Crafted DIY Studio & Bar, 807 SW Adams St., Peoria, Illinois for a Class K and Subclass 2 liquor license. Approval of this application would allow the applicant to operate a full service bar and host live entertainment at this location. A Class K license also allows the applicant to cater off site.

This site is located in Peoria's Warehouse District on SW Adams Street, just south of Oak Street. This location has historically held a liquor license dating back to 1980 and this site most recently operated as P-Mills Bar & Lounge. Nearby businesses include a coffee shop, retail vendors, a restaurant, business offices, vacant buildings and a baseball stadium. There is a nearby residential apartment at 301 Oak Street above Zion Coffee Bar.

Officer Slavens met with the applicant and inspected the site. The applicant plans to offer a workshop like setting at this establishment for their customers to do various crafts and painting projects. Site approval for this application will be for the first floor of this building only, as the applicant will be renovating the second floor for a separate residential apartment.

This site approval request appears to be appropriate for this location and would not be detrimental to the surrounding businesses or neighborhood, as it is located in an established commercial area of town. There are no traffic or parking concerns raised by this request.

The Peoria Police Department has no objections to this site approval request.
