Council Member Velpula requested clarification regarding the rezoning from a single family residential to a neighborhood commercial. Assistant Community Development Director Leah Allison said the Class C-N was a mixed-use designation that provided a variety of permitted uses, including Short-Term Rentals and commercial office space. She described the property located at 331 NE Perry Avenue and the proposed plans presented by the property owner.

Discussions were held on increasing mixed-use zoning trends, possible uses of the building at 331 NE Perry Avenue after rezoning, and the unique location of the property that contributed to the decision of Community Development Staff to propose the mixed-use zoning designation.

Council Member Riggenbach said he supported the rezoning application as presented, noting he recently attended meetings with stakeholders regarding revitalization efforts of the area. He said this type of rezoning could be an appropriate thing to consider for other parcels as well.

At the conclusion of his comments, Council Member Riggenbach moved to adopt an Ordinance rezoning property from Class R-3 (Single Family Residential) District to Class C-N (Neighborhood Commercial) District for the property located at 331 NE Perry Avenue; seconded by Council Member Oyler.

In response to Council Member Velpula regarding zoning designations of neighboring properties, Assistant Director Allison said they were zoned Residential, but there was a possibility that rezoning could be reconsidered for those parcels as well.

#### **NEW BUSINESS**

#### **East Bluff Evictions Update**

Council Member Riggenbach provided an update on the successful efforts of City Staff to negotiate eviction deadline extensions with SFR3 for East Bluff residents affected by notices to vacate issued in December 2022. He said on December 20, 2022, a virtual town hall meeting with residents and community stakeholders provided tenant rights information, recourse for actions against those rights, and resources for housing solutions. He said due to continued miscommunication regarding the incident in December, he asked for those involved to present at the February 28, 2023, City Council Meeting to provide more information. He asked residents looking for housing solutions to call Community Development Staff at 309-494-8600, or to call 2-1-1 in crisis situations for information and access to available resources.

#### **Smoke Shops in Peoria**

Council Member Jackson asked for a Report Back regarding the number of Smoke Shop locations currently in Peoria. She said a number of concerned citizens reported issues to her regarding the establishments, and she said the Council needed information to determine how to proceed.

## Peoria Public Schools Foundation - 365 Breakfast

Council Member Allen said the 8<sup>th</sup> Annual Peoria Public Schools Foundation 365 Breakfast was on Thursday, January 12, 2023, with breakfast pickup from 7:00-8:30 A.M. at the Hy-Vee on Sheridan Road. He said a virtual program would follow at 10:00 A.M. on the organization's Facebook page. He said Kouri Marshall, Community Activist and PPS Alum, was the keynote speaker, noting his history and impact in the community as well as the services and benefits provided by the Peoria Public Schools Foundation.

**Property Acquisitions** 

Council Member Kelly commended the Community Development Director Dulin for his continued efforts to streamline and improve the process to acquire properties after tax delinquency. He said coordination with other municipalities in the State of Illinois resulted in the 'Sale in Error' legislation proposition, which, if approved, would reduce waiting periods for property acquisitions and allow renovations or demolitions to begin sooner. He said this would ultimately reduce the effect of long-term blight on the neighborhood.
