

A site application has been received from Los Cabos Cantina & Grill, Inc., d/b/a Los Cabos Cantina & Grill, 7800 N. Sommer St., Suite 106, Peoria, Illinois, for a Class B, Subclass 3 liquor license. The approval of this application will allow this new restaurant to operate a full service bar for onsite consumption with a beer garden.

Officer Scott Jordan inspected the location which is part of the Pioneer Parkway Plaza, on Sommer near Pioneer Parkway and Candletree Lane. The plaza is comprised of offices, businesses and similar restaurants. The Fox Pub & Café, also in the plaza currently holds a Class B, Subclass 3A (sidewalk café) liquor license. This is a commercial area and the closest known residence is approximately 480 feet to the south west, which is an apartment complex. There are also residences approximately 618 feet to the south. The beer garden will be located at the east end of the restaurant and accessible through the bar portion of the restaurant and will have a second exit at the front.

This location previously operated as Jalapeno's which closed in May, 2014. At the time of its closing Jalapeno's did not hold a liquor license. Jalapeno's previously held a Class B and Subclass 3 liquor license, but the license was revoked by the Illinois Liquor Control Commission approximately 2 years ago for failure to pay required taxes to the Illinois Department of Revenue. Officer Jordan also learned through the finance department that Jalapeno's had failed to pay city HRA taxes since December, 2013.

Officer Jordan spoke to the applicant, Ms. Laura Tafoya, who stated she has no connection to the previous owner, Mr. Jose Leon. Ms. Tafoya said she negotiated with the landlord for the rent and purchased equipment left inside the restaurant from the Internal Revenue Service who had seized the equipment from Jalapeno's.

In 2011, the former owner was cited for selling alcohol to a minor and violation of classification for operating a beer garden without the proper license. No other issues or known complaints were found regarding the operation of a licensed restaurant at this location.

It does not appear that the approval of this application would be detrimental to the neighboring businesses or the residents in the area. There are no traffic or parking concerns raised by this request.

The Peoria Police Department has no objections to this site approval request.
