Finance Director/Comptroller Scroggins stated the City was approached three weeks ago with an opportunity to join a consortium with other local governments within the Ameren district to purchase natural gas for City facilities. Finance Director Scroggins said if the City joins the consortium, the estimated savings would be up to \$10,000.00 per year.

In response to Council Member Grayeb, Finance Director Scroggins said the City had not done this type of savings with natural gas in the past. City Manager Urich stated the City had participated in electricity aggregation in the past, on behalf of the residential customers, with an overall savings of \$11,000,000.00 over the past eight or nine years. He stated that the City currently participated with Homefield Energy for electricity, however, this contract would be for natural gas.

Council Member Grayeb inquired on when the contract would be up again for electricity. City Manager Urich responded he would provide that information at a later date.

In response to Council Member Grayeb, Finance Director Scroggins said citizens would have been notified about the option for electricity roughly nine years ago. At that time, citizens were given an opportunity to opt-out of the program. Finance Director Scroggins said this contract would be for City facilities and was not an aggregation for citizens at this time.

Council Member Grayeb moved to approve a Resolution authorizing the execution of a service agreement with the lowest responsible bidder for the supply of natural gas for City facilities; seconded by Council Member Ruckriegel.

Community Development Director Ross Black stated this amendment was to clarify and clean-up the current Sign Ordinance relating to off-premise signs. He stated this amendment provided more clarity for businesses who have off-premise signs as well as Staff when approving new locations.

Discussions were held regarding the situation on War Memorial at the Peoria Stadium site on how this Ordinance would not impact that situation.

In response to Council Member Moore, Community Development Director Black said the proposed Ordinance would change the cap to 90 signs throughout the City. He stated the current Ordinance limits signs and replacements in not only the City, but within the Council Districts as well.

In response to Council Member Grayeb, Community Development Director Black confirmed this Ordinance would not be applicable to real estate signs.

Discussions were held on the proposed cap and whether this should be increased. Community Development Director Black stated research would be done before the next Council meeting regarding the proposed cap.

In response to Council Member Jensen, Community Development Director Black stated the separation requirement for residential properties was being changed and, depending on the size of the sign, the sign needed to be 150-200 feet from a residential property. Council Member Jensen requested the current requirement.

At the conclusion of the discussion, Council Member Moore moved to receive and file the First Reading of an Ordinance amending Appendix A, the Unified Development Code, relating to off-premise signs; seconded by Council Member Riggenbach.

NEW BUSINESS

Video Doorbells

Council Member Jensen suggested, in light of recent crime, doing a registry of video doorbells. She said Springfield recently considered an Ordinance, a voluntary Ordinance, that Police would have a registry of residents who had video doorbells. She said if crime were to occur in a certain area, Police could check the registry for possible video footage from people who had video doorbells. She requested a Report Back on working with the companies that provided video doorbells.

First Annual Golden Shovel Award

Council Member Akeson wanted to bring attention to website www.appreciatepeoria.com, noting that on the home page there was an announcement to commend people that took the initiative to shovel their sidewalks. She said an inaugural golden shovel award would be given the first week in April and forms were provided on the website to nominate individuals. She said it was their hope to recognize fifteen individuals or neighborhood associations that had gone the extra mile while removing snow from sidewalks.

First Annual Neighborhood Award Reception

Council Member Moore wanted to recognize the Community Development Department for their Neighborhood Award Reception that took place on February 21, 2019. She recognized those who received awards at the reception and stated it was an outstanding event.

Mayor Ardis also commended the Community Development Department and the event.

Crime Notification Process

Council Member Montelongo spoke in regards to the communication plan for when there were significant crime issues and he requested Police Chief Marion and City Manager Urich, to provide an explanation.

Police Chief Marion spoke regarding the notification process and the opportunity to improve the process. He stated the system being considered contained three steps: an email to the neighborhood association and notification to the dispatch supervisor to post on Nextdoor; a press release; and a Code Red notification. He encouraged citizens to sign up for Code Red, their neighborhood associations and check out Crime View Mapping.

In response to Mayor Ardis, Police Chief Marion confirmed that information of those who signed up for Code Red would remain confidential.

Council Member Akeson appreciated the update regarding the crime notification process. She was concerned with the delay in notification and the lack of notification to those who were not signed up with neighborhood associations. She mentioned that Bradley University had utilized texting notifications with the students and inquired if Code Red could be used in a similar way.

She expressed a concern about there not being a text alert and inquired why the City was not utilizing that notification.

In response to Council Member Akeson, Police Chief Marion suggested ECC Coordinator Tuttle would have more information on Code Red. He stated that the Police were often notified after the fact, however, if it was an active situation, Code Red would be utilized.

Council Akeson requested the City Manager to provide more information regarding the immediate use of Code Red for notification.

Council Member Jensen suggested this was a high priority for the Council and she asked for a Report Back on alternatives.

Council Member Grayeb thanked those in attendance for the meeting at St. Paul's Episcopal Church, which involved neighbors concerned about their neighborhood. He stated he would also like to see an alert that would be sent to a certain area, where the crime occurred. He requested a presentation from the Police Chief on the protocol.

CITIZENS' OPPORTUNITY TO ADDRESS THE CITY COUNCIL/TOWN BOARD

Hearing no objection, Mayor Ardis granted Privilege of the Floor to those citizens wishing to address the City Council/Town Board.

William Jones, a citizen of Peoria and who assisted on the Alexa Scott campaign, stated his appreciation to Police Chief Marion for meeting with him. He thanked Council Member Grayeb and Mayor Ardis for the meeting last week, stating it was productive and he hoped to have more meetings. He suggested an increase in the reward in the Alexa Scott campaign and he requested to get together with the Police Chief to find a way to increase. He said this increase may result in more people willing to talk. He stated he was working with Springdale Cemetery and he stated his aunt would be at Springdale the last Saturday in April to speak regarding history in Peoria.
