Our Commitment

- · History of being the leaders in mental health
- We opened Peoria's first inpatient mental health unit in 1954
- Have helped thousands of kids since our child and adolescent unit opened over 30 years ago
- In 2002, when Zeller and St. Francis closed their units, we doubled down by expanding our adult services and sustained our commitment to area kids needing our services
- In 2019 we formed UnityPlace, bringing together Human Service Center, UnityPoint Health, and Tazwood Mental Health to provide a national model for a coordinated/comprehensive approach to mental health, addiction, prevention, and education services
- We have stepped up time and again, we will continue to carry on to fill this need. We see it as our responsibility.

The Issue – Kids Are in Crisis

- Methodist has the only inpatient beds in Central Illinois for kids suffering from mental illness
- We average 60 admissions per month
- Over the past 5 years, nearly 2,600 kids have been turned away due to lack of available beds
- In a recent Community Health Needs Survey of 10th- grade students from the Tri-County Area:
 - Over 31% indicated that in the past 12 months, they felt sadness or hopelessness almost every day for at least 2 weeks, causing them to stop participating in some of their usual activities
 - 17% of 10th graders indicated they seriously considered attempting suicide in the past 12 months

The Need

- New Space BUT Goes Beyond a Capacity Issue:
 - · The unit has an institutional feel and lacks natural lighting
 - No outdoor green space
- Kids should stay near loved ones, transferring them is heartbreaking:
 - · Sending to distant communities is hard on everyone
 - Delays treatment
 - Results in long boarding times in the ED
- A safe, welcoming, trusted space for providers to collaborate
- Adequate reimbursements

Other Key Features

- Integrate all Child and Adolescent Behavioral Services
 - Inpatient beds
 - Outpatient services, including physician offices
 - 24/7 assessment center
- Increase up to 44 future beds from the current 23
- Improve quality, safety, and experience of care
 - Experiential therapy for music therapy, art therapy, a gym, and a specialized sensory room
 - Separate neighborhoods for children and adolescents
