





Building and Zoning staff from the Community Development Department have reviewed the above listed request. Following is a summary of the results:

- 1. The property is currently zoned I-1 (Industrial/Business Park). Distilling is a permitted use as a Craft Distillery when production is less than 15,000 gallons of beverage grade alchohol per year. Production of 15,000 gallons or more per year requires a Special Use for Beverage Manufacturing.
- 2. New tenant would be a change of occupancy to a higher hazard classification. Stamped drawings by a registered design professional will be required before building permits will be issued.
- 3. All work shall adhere to 2012 International Code series, 2018 IECC, 2014 NEC, 2014 Illinois Plumbing Code, and 2018 Illinois Accessibility Code.

The Community Development Department does not object to the requested liquor license.
