Question by Joe Alexander how often are Façade Improvement Program funds exhausted? Response by Jim Scroggins Historically, each façade program received funds on an annual basis to maintain funding on an ongoing basis.

Bruce Budde moved to receive and file the 2020 TIF audit report; seconded by Scott Sorrel Approved by viva voce vote.

### II. Extension of Warehouse District TIF, Hospitality Improvement Zone

Jim Scroggins provided information on the rationale for pursuing extension of each TIF. The rational clarified that the extension of the TIFs was to extend the life if the TIF and did not include the expansion of the geography of the TIFs. The factors discussed included refinancing of the Hotel Pere Marquette bonds, allowing the project to pay for itself; for the additional project reimbursement at Four Points and the demand by local developers seeking to begin projects as key factors for consideration of TIF extension.

No motion required.

III. **Urban Decay Abatement Ordinance.** Jim Scroggins reviewed the process for formation of Urban Decay Abatement Board per the Ordinance. Called for a motion to combine the Joint Review Board and Urban Decay Tax Abatement Board

**Discussion:** Mick Willis, Mike McKenzie expressed some concerns, Gene Olson asked if there had been any changes to ordinance, Jim Scroggins indicated no changes to ordinance, Additional discussion of the abatement schedule was suggested. Mick expressed he was not comfortable and needed more input from his board. Further discussion impact of Ordinance would be confined to City/County impact. Bruce Budde ask what is the EAV for the area? Asked how many properties would be eligible for inclusion approximately? Also clarified this would be a TIF carve out? Scott Sorrell commented municipalities generally ask for recommendation of approval. The JRB can endorse the approval as a recommendation.

Motion to recommend approval of Ordinance and Joint Review Board will act as Urban Decay Tax Abatement Board was made by Scott Sorrell and Seconded by Gene Olson. Motion passed unanimously with Mick Willis and Michael McKenzie abstaining from the vote
