

ORDINANCE AMENDING THE CITY OF PEORIA BUDGET FOR FISCAL YEAR 2015 RELATING TO THE RECEIPT OF A GRANT FROM THE U.S. ENVIRONMENTAL PROTECTION AGENCY TO CONDUCT COMMUNITY-WIDE HAZARDOUS AND PETROLEUM ASSESSMENTS AT ELIGIBLE BROWNFIELD SITES, IN THE AMOUNT OF \$400,000.00; THE RECEIPT OF A GRANT FROM THE UNITED STATES SMALL BUSINESS ADMINISTRATION FOR A STARTUP IN A DAY GRANT IN THE AMOUNT OF \$50,000.00; THE RECEIPT OF A GRANT FROM ILLINOIS AMERICAN WATER FIREFIGHTER GRANT FOR THE PURCHASE OF FIRE HELMETS AND EYE PROTECTION, IN THE AMOUNT OF \$800.00; THE RECEIPT OF A GRANT FROM FM GLOBAL FOR THE PURCHASE OF TWO TYPES OF SMOKE DETECTORS AND STOVETOP FIRE SUPPRESSION SYSTEMS IN THE AMOUNT OF \$2,000.00; THE RECEIPT OF A GRANT FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION SUSTAINED TRAFFIC ENFORCEMENT PROGRAM (STEP) GRANT IN THE AMOUNT OF \$8,735.00; AND THE RECEIPT OF A GRANT FROM THE ILLINOIS DEPARTMENT OF REVENUE FOR THE TOBACCO ENFORCEMENT GRANT IN THE AMOUNT OF \$11,000.00.

WHEREAS, the City Council did adopt, on November 25, 2014, the Budget for Fiscal Year 2015 of the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2015 Budget should be amended in order to add certain expenditures that were not included in said 2015 Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

Section 1. The Budget for Fiscal Year 2015 of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:
