

ORDINANCE NO. 17,753

AN ORDINANCE AMENDING THE CITY OF PEORIA 2020 – 2021 BIENNIAL BUDGET RELATING TO THE GENERAL FUND BUDGET FOR FY 2020 IN THE AMOUNT OF \$30,000, THE EAST VILLAGE TIF FUND IN THE AMOUNT OF \$5,000 AND THE WAREHOUSE DISTRICT TIF FUND IN THE AMOUNT OF \$5,000 TO FUND ADMINISTRATIVE AND START-UP COSTS TO DELIVER THE FULL-TIME PRESENCE OF A NON-PROFIT MICROLOAN AND FINANCIAL SERVICES ORGANIZATION (JUSTINE PETERSEN)

WHEREAS, the City Council did adopt, on November 5, 2019, the 2020 – 2021 Biennial Budget for the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2020 – 2021 Biennial Budget should be amended in order to add certain expenditures that were not included in said 2020 - 2021 Biennial Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

Section 1. The 2020 - 2021 Biennial Budget of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:


