Enclosed is an application from the *Peoria Friendship House of Christian Service* for a Class H temporary liquor license. This license will be used on Saturday, June 9, 2018 in the 400 block of Hamilton Blvd., between Jefferson Street and Madison Avenue. The Peoria Friendship House is hosting their 2nd annual *Over the Edge Peoria* rappelling fundraiser between the hours of 8:00 a.m. and 4:00 p.m. at the Chase Bank Building, 411 Hamilton Ave., Peoria, Illinois. Approval of this license will allow for the sale and on-site consumption of alcoholic beverages during this event.

Security will be provided by two off duty Peoria Police Officers and volunteers from the Peoria Friendship House. Proceeds from the event will benefit the *Peoria Friendship House of Christian Service*, a registered not-for-profit corporation through the Illinois Secretary of State's Office.

Officer Kevin Slavens conducted a background check of the officers listed on the application. Mr. Robert Montgomery, 331 Fulton St., Peoria, Illinois is the president and Ms. Emiline Caracheo, 1013 N. Glenwood Ave., Peoria, Illinois is the secretary of this organization. Mr. Wesley Garrard will be the event chairman. Nothing was found that would prevent this organization from receiving the requested license.

The Peoria Police Department has no objections to this temporary license request.

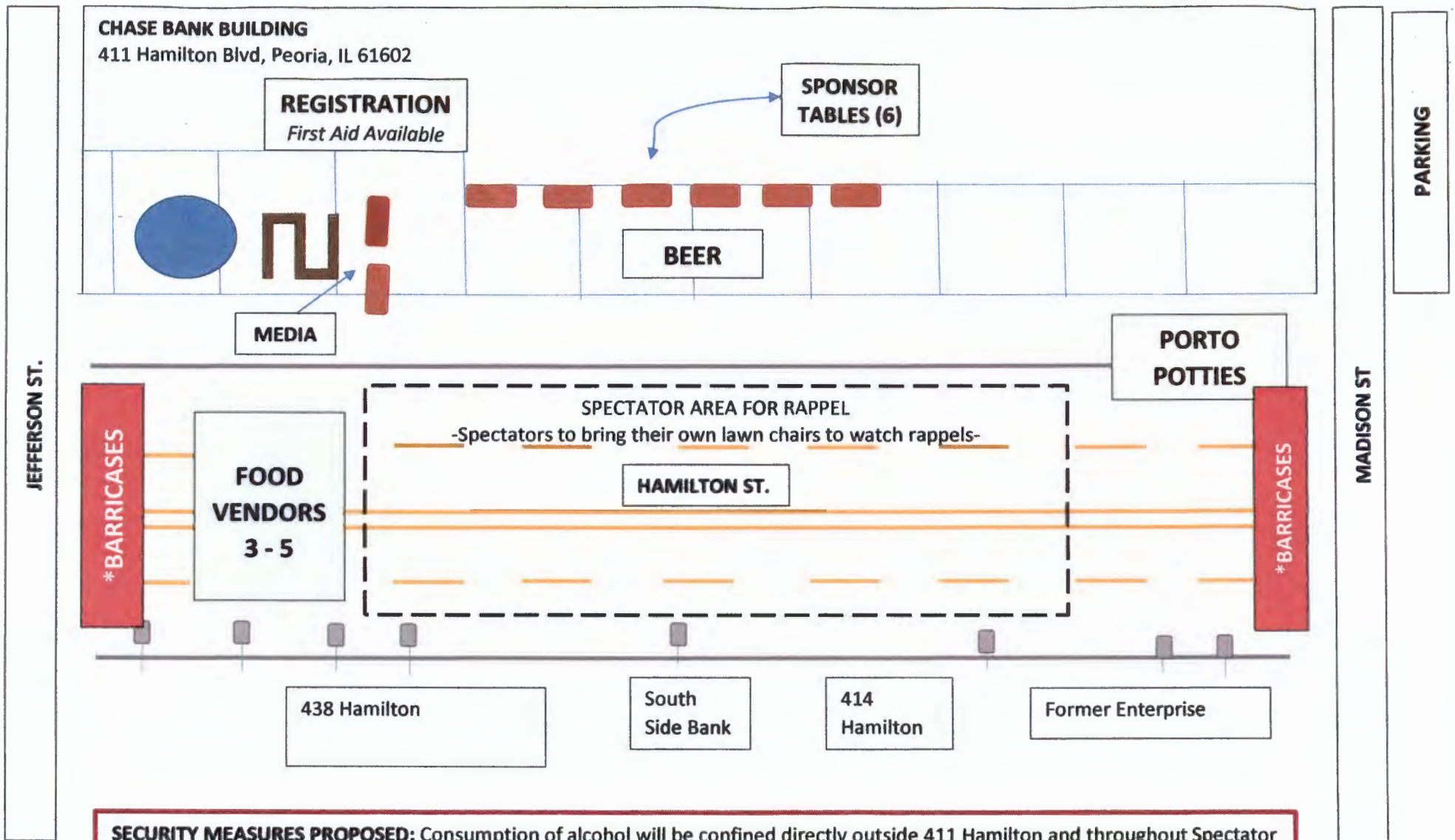


