

ORDINANCE 17,590

AN ORDINANCE REZONING CERTAIN PROPERTY FROM THE PRESENT CLASS C-N (NEIGHBORHOOD COMMERCIAL) DISTRICT TO A CLASS R-4 (SINGLE FAMILY RESIDENTIAL) DISTRICT FOR THE PROPERTY IDENTIFIED AS PARCEL IDENTIFICATION NO. 18-18-152-002, WITH AN ADDRESS OF 3030 W MARQUETTE STREET, PEORIA, ILLINOIS.

WHEREAS, the property herein described is now zoned Class C-N (Neighborhood Commercial) District, and;

WHEREAS, said petition was directed to the Planning & Zoning Commission as directed by Section 2.8 of Appendix A, the Unified Development Code of the City of Peoria, and

WHEREAS said Planning & Zoning Commission held a public hearing on June 7, 2018, pursuant to a notice of the time and place thereof in a newspaper of general circulation in the City of Peoria, not less than fifteen (15) days nor more than thirty (30) days prior to said hearing as required by law; and no written protest was made by the owners of twenty percent (20%) of the frontage immediately adjoining or across from the frontage proposed to be altered; and

WHEREAS, said Planning & Zoning Commission has submitted its report of said hearing and the City Council finds that to permit such rezoning will not adversely affect the character of the neighborhood, and will not unduly burden the public utility facilities in the neighborhood;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS, AS FOLLOWS:

Section 1. That Appendix A, the Unified Development Code of the City of Peoria, and the District Map made a part of said Code are hereby amended by changing the classification of the following described property to Class R-4 (Single Family Residential) District instead of C-N (Neighborhood Commercial) District:

Legal Description:

Lot 5 and the East 15 feet of Lot 3 and the West ½ of Lot 7 of Park Lane Subdivision, being a part of the Northwest ¼ of Section 18, Township 8 North, Range 8 East, of the 4th Principal Meridian, all located and situated in Peoria County, Peoria, IL.

Parcel Identification Number: 18-18-152-002

Section 2. All provisions of Appendix A, the Unified Development Code of the City of Peoria, and the District Map made a part of said Ordinance shall extend to said above-described premises as herein reclassified and rezoned.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval according to law.
