## **ORDINANCE 17,588**

AN ORDINANCE AMENDING THE CITY OF PEORIA 2018-219 BIENNIAL BUDGET RELATING TO CDBG FUND AND HOME FUND TO RECOGNIZE THE INCREASE IN GRANT FUNDING AND THE CORRESPONDING EXPENDITURES IN THE AMOUNT OF \$394,044; AND THE TRANSFER OF CDBG PROGRAM INCOME TO THE CAPITAL FUND IN THE AMOUNT OF \$15,468.

WHEREAS, the City Council did adopt, on December 5, 2017, the 2018-2019 Biennial Budget for the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2018-2019 Biennial Budget should be amended in order to add certain expenditures that were not included in said 2018-2019 Biennial Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:

<u>Section 1.</u> The 2018-2019 Biennial Budget of the City of Peoria is amended by adding the following expenditures and revenues in the designated funds:
