Program Description

The City of Peoria is accepting applications for down payment assistance within Qualifying Census Tracts (QCTs). The program can provide \$5,000 or up to 10% of the purchase price in down payment assistance to owner-occupied property purchases within the QCTs. The homes must be single family with a final sale price under \$125,000.
