Kavan Shay, Owner, presented a Site Application for a Class B (restaurant, 50% food) Liquor License, with a Subclass 3A (sidewalk café) for 212 SW Water, Suite B.

In discussion with Chairman Cassidy, Mr. Shay said his barbecue tavern would be located inside the former Cattleman's Club Car of the River Station building. He said the size of the business was just under 3,000 square feet, with a dining area of 80 seats. He said seasonally, they would like to have an additional six tables for a total of 24 seats outside. He said they planned to be open in the spring and he said his establishment would be a restaurant with a full service bar.

In more discussion, Mr. Shay gave a brief description of the location of his business. He said they were located on the south side of Martinis and he said his main entrance was on Water Street. He also explained that patrons for the sidewalk café would be escorted outside and they would be served the same way as if they were inside the restaurant. He went on to say he planned to have one to two dedicated servers and/or bussers for that area.

In response to Chairman Cassidy's question in regard to the width of the sidewalk, Mr. Shay said he believed it was approximately 10 feet wide. He said they planned to have a removable railing system around the outside area and he said they would not be impeding the bike/walk trail nearby.

In discussion with Commissioner O'Brien, Mr. Shay reported that his hours of operation would be from 11 a.m. to 2 p.m. for lunch, and then from 5 p.m. to 10:00 p.m. for dinner, five to six days per week. He said they might close on Sundays and Mondays, depending upon the demand. He then said they may open a little earlier on Saturdays in order to take advantage of the Riverfront Market.

Liquor Investigator Jordan confirmed that the outside area could not be open past midnight. He also commented about the fact that there were two taverns at that location, and he cautioned the owner to make sure alcohol would not be taken from one location to the other.

During more comments, Mr. Shay said he wanted to be open in early April. Deputy Corporation Counsel Williams clarified that the applicant had to be open for business within six months of the site approval by the City Council, unless an extension was requested.

Hearing no more questions, Chairman Cassidy called for the motion.

Commissioner O'Brien moved to recommend approval of the Site Application for a Class B (restaurant, 50% food) Liquor License, with a Subclass 3A (sidewalk café) for 212 SW Water, Suite B; seconded by Commissioner Miller.


