Security for this event will be provided by Peoria Police Officers. Lt. Earnest McCall will coordinate security with Mr. Nick Conrad from the Peoria Park District.

Officer Kevin Slavens conducted a background investigation of the officers of this organization. Nothing was found that would prevent this organization from receiving the requested license.
