The Pathway of Hope is a Parent Support and Education program that provides families resources and services guided by a Family Care Coordinator to use the power of relationships with our Southside neighbors to reach selfsufficiency and home ownership. There are three phases of the Pathway of Hope: Creating a Safe Space, Enlisting Soldiers on the Pathway of Hope, and Community Development Expansion. This safe space is created through ethical practices, asset-based community development principles, and culturally competent resources that provide parent support, education, and youth leadership and enrichment. Southside Community Center helps each family to realize their value through the VALUES Principle: Vision, Attitude, Leadership, Understanding, Excellence, and Serving. After fostering this safe space FCCs meet with the family and do an Assessment and Service Plan to initiate parent lead case management. SCC embodies a tier-based triage system of care and uses asset-based principles to capture what assets children and their families already have, identify needs based on screenings and desires of the family to set goals and receive support to overcome obstacles. The goal is to walk with them on their path and provide off-ramps out of cycles of generational poverty.

After assessing their strengths and identifying barriers to self-sufficiency together we set goals and celebrate achievements along with receive ongoing support through the many services and connection provided with SCC. With weekly guidance from a Family Care Coordinator and volunteer parent mentors, families access community

Since its beginning on the Pathway to Hope has consisted of 12 families. SCC plans to enlist five new families in their Pathway of hope, for an estimate of 35 individuals based on the average size of household of our current Soldiers on the Pathway of Hope. The Pathway of Hope has moved 8 families out of Harrison homes; 3 of these families are now in fair market value homes looking to become first time home owners. Oreenna is a single mother of 5 and a survivor of domestic violence. It was our grassroots outreach that brought a hot meal to the housing authority weekly that connected her to Southside Community Center. Once enlisting in the Pathway of Hope she has bought a vehicle, gotten her children into private school, went back to school and moved out of public housing into a fair market rental. She was pregnant a few months after starting the Pathway of Hope. Her volunteer care coordinator was her support person at the hospital when she went into labor a month early. She is seeing her dream of owning a bakery and catering business come to life as she is more than halfway through her culinary arts training at the local community college and learning how to create a business plan through the SBA.

The ultimate goal is Self-Sufficiency through living wage employment and home ownership. These services include a large list of community service providers that support our families values and goals on their pathway of hope.

SCC is aware of the level of trauma our children experience from the constant fear of gun violence in the community daily. Pastor Irene talks about the strain on our children and their families and helps volunteers understand that gun violence is a precipitating effect of environmental violence. This is in addition to the top known factors of poor childhood outcomes: domestic violence, substance abuse, and untreated mental health struggles in the parent. Because our community suffers from all three; in addition to parental stress, lack of access to quality healthcare, increase mental health struggles, isolation, substance abuse, isolation, lack of support, and food insecurity SCC addresses all of these through enlisting Families on the Pathway of Hope.

This program has been in operation since 2019 when Southside Community Center received the Housing Action Illinois - AmeriCorps grant.

This program focuses on the performance metrics of housing stability, education and training, community building, participation numbers, and outreach efforts. We will measure these out ones through our screening assessments done with the parents. These metrics have grown in our current participants and they show the success of support in the community and that relationship building is essential.

For Workforce Training programs only, how many clients will you connect to permanent employment? per the Family care plans, we have 3 GED students and 3 enrolled in ICC Cradle to Career program and 4 of our families are currently enrolled in ICC programs. Our First is scheduled to graduate December 2023.

Southside Community Center will hire a database developer to create a comprehensive tracking system of our participants. The data is currently collected on paper and all on file. Our initial Assessment and Service Plan addresses demographic of the participants and the weekly meetings address social-emotional health as well as parent lead case management.

Just how we build our program we are looking forward to continuing our monthly food and baby supplies giveaways. Our outreach and community organizing is a cornerstone of Southside Community Center. We target Harrison Homes and the neighborhoods west of Western. We have recently absorbed Adopt-A-Block team that will go door to door in the neighborhoods on the 1st and 3rd Saturdays to inform and resource our neighbors with information, services and action items.

we see anecdotally, that every child born to a Black woman was born to a single parent. Because of the concentration of single families in poverty in our target area, our programs have been tailored to connect with some of the most vulnerable disenfranchised families in our city. Our mantra "if folks knew better they would do better." We also know that parents are the lifelong teachers in the child's life and therefore, Pathway of Hope uses creative engagement strategies to CONNECT with target families by going to their space to build relationship and trust. We invite families to come into our space and CONNECT with our parent led support group called MOMS Group, Moms Offering Moms Support Group. We continue to Connect while offering GROW Opportunities as we begin to dismantle the protective wall they have built. Life skills, parenting, pregnancy resource, are in-house. We know we can earn relationship currency by loving on their kids well through our youth leadership and enrichment programing. Our volunteers are trained by Pastor Irene in trauma informed, trust-based, dismantling poverty, racial justice and effective engagement strategies. The Family Care Coordinator and Parent Educator are currently volunteers that help support and educate our parents. Family care coordinators offer the Pathway of Hope to those who do tier 2 and tier 3 interventions for youth who have behavioral symptoms associated with the stress of trauma and lack. Parents are highly stress and overwhelmed with basic survival and the demands of parenting. So we offer a meal with our programing. For those who enlist in the Pathway of Hope, our asset-based case management program designed to help families work toward self-sufficiency, we offer material goods that can not be purchased with SNAP benefits as incentive and reward for meeting goals. Their demographics, assets and needs are captured in the Family Care Plans, when their goals are met they earned household cleaning items like baby supplies, cleaning products, Costco Toilet Paper. We believe that everyone has something to offer the community and we work with our support group to identify service projects they can execute to SERVE our neighbors.

We have MOU in place with Methodist School of Nursing, and Pregnancy Resource Center. We are working collaboratively with Peoria Grown to provide fresh fruit an vegetables. We are a partnering with Trewyn Wraparound center and the Hands Up Peoria pantry. Churches like Pekin 1st, United Presbyterian and Redeemer Lutheran help us to fill the gaps in the system of care the agencies like PCCEO that provide programs like LiHeap, Headstart. Because of our MOU with Midwest Food Bank we are able to cut our food budget more than 60%.

Racial). When we understand that today's racial segregation and inequity in Peoria is a result of intentional policy, we can begin to be intentional about how we can right these historical wrongs. SCC seeks to prioritize racial equity and calls for policies that seek to benefit the same neighborhoods that were redlined. United States Zip Codes States "The people living in ZIP code 61605 are primarily black or African American. There are also an extremely large number of single parents and an extremely small number of families. The percentage of children under 18 living in the 61605 ZIP code is extremely large compared to other areas of the country." The median home value of \$43,900 is nationally considered low and drastically different to the three surrounding zip codes of 61602 at \$217,500, 61606 at \$ 99,900, and 61604 at \$90,400 (ZIP). This radical difference between Census Tracts 2 and 3 and its surrounding Tracts shows the need for intervention through programs that focus on family supportive services to those that face a higher likelihood of community disengagement without the proper intervention strategies.

Southside Community Center believes that relationship building is essential and is shown through the Medical Home Model. The Agency for Healthcare Research and Quality divides the definition of the Medical Home Model into five sections, Comprehensive Care, Patient-Centered, Coordinated Care, Accessible Services, and Quality and Safety. This relationship based and research based model is based on trust between Family Care Coordinators can be that one constant, stabilizing relationship in a family's life who may struggle with relationship trauma. Healing and transformation happen best in the context of relationships, but it's important to remember that without transparency and honesty, there can be no trust. And without trust, there can be no relationship. Our



engagement strategies therefore must be intentional so that our BIPOC families can see professional BIPOC people in leadership positions. We must instill the value that we know what we need AND that we have the ability to achieve it. Then we must make the connection to resources and support so that we can learn to resource ourselves. This includes finding multiple ways to enrich the lives of those in our community by engaging with people who have been trained and equipped to work together in solidarity for the sake of our shared future.

This training includes the Circle of Security International that focuses on children's attachment needs as well as Strengthening Families International training of the community members in the Parent Cafe Program.

Pekin First Church of the Nazarene was our original and sole funder in the beginning. As we began to build a donor base we required less and less of their financial support. Their Finance Department managed all of our funds. We have recently built and are transitioning to using a new accounting software to record income and expenses as they happen using the chart of accounts created through the budgeting process. Each grant received will have its own account number and associated expenses will be tracked under that category. The balance sheet produced monthly will show each grant separately so we can track what remains. Reconciliation happens on a monthly basis. Staff will be required to track hours spent on particular grant-funded projects so that where appropriate, funding can be divided between general operating work and grant-specific work and expenses.

FCC would receive payment of \$15 an hour for 0.5 FTE equaling 30,000. Part time Grant Implementation and Data Analysis equivalent to \$1,800. Program Director FTE 0.25 at \$15 an hour cash value of \$7,500, Parent Educator Volunteer Time at \$32 an hour FTE 0.25 at valued at \$97,500 in-kind contribution, Administrative work at \$15 an hour cash value of \$15 an hour \$7,500. Totaling to \$117,900.

Our current equipment that is used for Pathway of Hope includes 2 iMac valued at 500 and the SCC van at \$10,500 cash equivalent. For a total in equipment cost of \$14,294.00

Circle of Security International Early Intervention Program for Parents and Children Online Training offers in person large group trainings or online individual trainings. To avoid travel expenses SCC is using the online training at \$1,000 a person for three FCCs, our current first employee doing administrative work, and the volunteer Parent Educator. A total of 5 employees totaling to \$5,000. Strengthening Families In-Person Parent Cafe Training is a evidence based community development training to engage 20 adults in community building totaling \$3,600. Database development by known developer Nina Ortega at an estimate of \$45 an hour, 0.5 FTE, for 6 months totals \$21,600 for the complete total of Training and Contract work of \$30,200.

Pathway of Hope relies heavily on the in-kind contribution of Volunteer Time at \$32 an hour for 9 volunteers 6 hours a week. The time estimated for this project includes five parent mentors for the families enlisted on the Pathway of Hope, two cooks, and two childcare providers.

With the Pathway of Hope Expansion Utilities, Maintenance, Facility Supplies, and Office Expenses are expected to increase. We reflect this increase by multiplying these portions of the SCC budget by 24%. Current Rent, Pest Control and Janitorial Services were also multiplied by 24% to fill the gap in the budget in order to even the funds and provide additional services to our population. This totals in general administrative cost is \$7867.2.
