

## ORDINANCE 17,556

### AN ORDINANCE AMENDING CHAPTER 28 OF THE CODE OF THE CITY OF PEORIA PERTAINING TO PARKING FINES AS PRESCRIBED IN SECTION 28-83 OF THE CODE OF THE CITY OF PEORIA

WHEREAS, the City of Peoria IS A HOME RULE UNIT OF GOVERNMENT PURSUANT TO Article VII, Section 6 of the Constitution of the State of Illinois 1970, and may exercise any power and perform any function pertaining to its government and affairs including regulating traffic flow of its streets;

WHEREAS, the City of Peoria desires to utilize a mobile ticket writing solution for issuing parking citations and such solution requires a service fee for each fine collected;

WHEREAS, the City of Peoria desires to pass the fee for the mobile ticket writing solution on to the violators receiving the tickets by raising the amount of settlement for violation, as defined in Sec. 28-83 of the Code of the City of Peoria by \$5;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS AS FOLLOWS:

**SECTION 1.** Section 28-83 of the Code of the City of Peoria is hereby amended by adding the following underlined words and deleting the following stricken words:

#### **Sec. 28-83 Amounts of settlement.**

- (a) Any person accused of violating those sections of this chapter set forth in this section may settle and compromise the claim against him for such violation by paying, in person or by mail, to the city treasurer, the following amounts:

(1) The sum of ~~\$15.00~~ \$20.00 within seven days and the sum of ~~\$20.00~~ \$25.00 after seven days and within 30 days of the time of such offense was committed, for violations of the following sections of this chapter.

- a. Sec. 28-256. Thirty-minute zones.
- b. Sec. 28-257. One-hour zones.
- c. Sec. 28-258. Two-hour zones.
- d. Sec. 28-259. Three-hour zones.
- e. Sec. 28-260. Four-hour zones.
- f. Sec. 28-298. Overtime parking at meter.
- g. Sec. 28-250. Parking in certain areas for more than two hours between 2:00 a.m. and 6:00 a.m.

(2) The sum of ~~\$15.00~~ \$20.00 within seven days, and the sum of ~~\$20.00~~ \$25.00 after seven days and within 30 days of the time such offense was committed, for violations of the following sections of this chapter:

- a. Sec. 28-246. Parking in specified places, except for subsections 28-246(a)(1)m. and 28-246(a)(2)b.
- b. Sec. 28-252. Prohibited zones.
- c. Sec. 28-253. Limited prohibited zones.
- d. Sec. 28-261. Parking in front of schools.
- e. Sec. 28-262. Parking in space reserved for funeral.
- f. Sec. 28-263. Parking in private parking lots.
- g. Sec. 28-264. Parking in public parking lots.
- h. Sec. 28-265. Parallel parking in wrong direction.
- i. Sec. 28-266. Parking in violation of signs.

- j. Sec. 28-267. Moving vehicle within the same block.
- k. Sec. 28-268. Parking on congested streets.
- l. Sec. 28-269. Parking for purpose of repairing, etc.
- m. Sec. 28-270. Lights on parked vehicles.
- n. Sec. 28-295. Parking at meter.
- o. Sec. 28-299. Extension of legal parking time.
- p. Sec. 28-254. Prohibited parking during certain hours.
- q. Sec. 28-367. Standing or parking in taxicab stands.
- r. Sec. 28-368. Standing or parking in bus stops.
- s. Sec. 28-369. Standing or parking in freight loading zones.

(3) The sum of ~~\$18.00~~ \$23.00 within seven days, and the sum of ~~\$23.00~~ \$28.00 after seven days of the time such alleged offense was committed, for violation of the following sections of this chapter:

- a. Sec. 28-169. Vehicles obstructing traffic.
- b. Sec. 28-271. Unattended motor vehicle.

(4) The sum of ~~\$40.00~~ \$45.00 within seven days, the sum of ~~\$50.00~~ \$55.00 after seven days, and the sum of ~~\$60.00~~ \$65.00 after 30 days of the time of such offense was committed, for violation of sections 28-246(a)(1)m. and 28-246(a)(2)b.


(5) The sum of ~~\$50.00~~ \$55.00 within seven days, the sum of ~~\$75.00~~ \$80.00 after seven days and the sum of ~~\$100.00~~ \$105.00 after 30 days from the time such offense was committed, for violation of sections 28-386 through 28-391, inclusive. This violation may be enforced each 24 hours.

SECTION 2. This ordinance shall be in full force and effect on June 1, 2018 after its passage and approval according to law.
