AN ORDINANCE AMENDING THE CITY OF PEORIA 2020 – 2021 BIENNIAL BUDGET RELATING THE CDBG FUND AND CAPITAL FUND TO REALLOCATE CDBG PROGRAM INCOME TO THE CAPITAL FUND, IN THE AMOUNT OF \$5.052.00; AND TO ADJUST THE CDBG FUND AND HOME FUND REVENUES AND EXPENDITURES TO REFLECT THE 2020 FEDERAL GRANT AWARD.

WHEREAS, the City Council did adopt, on November 5, 2019, the 2020-2021 Biennial Budget for the City of Peoria; and
