Juan Conciléon, Owner, Taqueria Jalisco Antojitos Mexicanos, presented a request for a Class B (Restaurant, 50% food) Liquor License at 2200 W. War Memorial Dr., #DU19A.

In discussion with Chair Pro Tem Jordan, Mr. Conciléon said they wanted to close off an area in the mall for a liquor license. He handed out a drawing to the Commission showing the area. In discussion, he indicated he would have wait staff to help customers and he said they wanted to serve beer only.

In response to a question from Commissioner Winkler regarding the enclosed space, Mr. Conciléon confirmed there would be a temporary wall located in the food court area.

Commissioner Hounwanou expressed his concerns regarding how to control individuals from possibly being able to take alcohol outside of the designated area. He then asked if the area had been approved by the mall. In response, Mr. Conciléon confirmed the area had been approved by the mall.

Liquor Investigator Linthicum expressed the Police Dept. concerns about the open-air free movement with a cafeteria style setting permitting alcohol to be carried from the POS (point of sale) and not into a secured area adjacent to the business.

Chair Pro Tem Jordan commented it would have been nice to have something submitted by the mall confirming approval of the designated area. During discussion, the applicant confirmed the area was open for anyone to utilize while shopping at the mall and not just for their customers only.

Commissioner Winkler also shared the same concerns regarding the proposed area. It was mentioned that there was already a history with the Police Dept. having issues with juveniles at the mall.

Fire Engineer Perrin reported life safety codes that needed to be corrected for the establishment before a C of O (certificate of occupancy) could be issued.

There being no further questions or comments, Chair Pro Tem Jordan called for a motion.

Commissioner Winkler moved to recommend <u>denial</u> of the request for a Class B (Restaurant, 50% food) Liquor License at 2200 W. War Memorial Dr., #DU19A; seconded by Commissioner Hounwanou.

Chair Pro Tem Jordan stated this recommendation would be heard at the City Council Meeting to be held on Tuesday, April 25, 2023, at 6:00 p.m.

After the vote, Christell Frausto said she wanted to speak on behalf of the Hispanic Chamber of Commerce. She said she was familiar with the operation of this families' restaurant, and she said would like to assist them with their application. She explained it was traditional for them to have a beer with their food.

In response, Chair Pro Tem Jordan said the problem was the way the site was set up and he went on to say he did not believe there would be a problem if it was a closed off restaurant within the mall.





Dear Mayor Ali,

Enclosed is a site application from Juan L. Alejandre Concileon, d/b/a Taqueria Jalisco Antojitos Mexicanos, 2200 W. War Memorial DU19A for Class B (restaurant, 50% food). Approval of this site application will allow the applicant to operate as a restaurant with full bar service.

Officer Richard Linthicum inspected the site but was not able to get ahold of the applicant after several phone calls. This site is located in the Northwoods Mall open food court. This area is commercial and nearby businesses include retail shopping that caters to all ages.

The proposed site is not within a standalone location, rather it is in an open seating area about 15 yards removed from the point of sale. The restaurant is a self-service type, where the customer orders at the counter and then seats themself. Alcohol would be carried into the open area by the customers and then into a "stanchioned" area according to a blueprint provided.

The Peoria Police Department has concerns about the open-air seating with alcohol being carried from the POS and not into a secured area adjacent to the business. It appears that this request is not appropriate for the proposed location and would be detrimental to the family friendly shopping environment and surrounding businesses.
