AN ORDINANCE AMENDING THE CITY OF PEORIA 2021 REVISED ANNUAL BUDGET RELATING TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUND TO RECOGNIZE THE RECEIPT OF ADDITIONAL GRANT FUNDS FROM THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO PREVENT, PREPARE FOR, OR RESPOND TO COVID-19 IN THE AMOUNT OF \$795,903 AND THE CORRESPONDING EXPENDITURES; REDUCE THE 2020 CDBG GRANT FUNDING IN THE AMOUNT OF \$314 AND CORRESPONDING REDUCTION IN EXPENDITURES AND TO REDUCE THE HOME FUND TO RECOGNIZE THE DECREASE IN THE HOME INVESTMENT PARTNERSHIP GRANT IN THE AMOUNT OF \$105 AND THE CORRESPONDING REDUCTION IN EXPENDITURES

WHEREAS, the City Council did adopt, on November 11, 2020, the 2021 Revised Annual Budget for the City of Peoria; and

WHEREAS, the City Council and Administration have determined that said 2021 Revised Annual Budget should be amended in order to add certain expenditures that were not included in said 2021 Revised Annual Budget; and

WHEREAS, the City of Peoria has adopted the budget procedure for appropriation pursuant to Illinois Compiled Statutes, 65ILCS 5/8-2-9.1 et seq. as set forth in Chapter 10, Article III of the Peoria City Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS that:
