Programs must meet the criteria of one of five priority areas: Thriving Neighborhoods, Empowered Youth & Young Adult, Restorative & Resilience, Intervention, or Violence Reduction. For these categories the minimum funding request is \$50,000 and the maximum funding request is \$400,000. All programs must be evidence-based and have measurable results. A total of \$1,200,000 is available for violence prevention with \$700,000 in federal funding from the American Rescue Plan and \$500,000 in state funding from the Illinois Department of Commerce and Economic Opportunity (DCEO).

There is also funding available specifically for Workforce Training. In addition to measuring the number of people served, these programs must also measure how many clients are connected to permanent employment. The minimum request for Workforce Training is \$150,000 and the maximum is \$300,000. A total of \$300,000 is available for Workforce Training in state funding from the Illinois Department of Commerce and Economic Opportunity (DCEO).

Eligible applications will be reviewed by the Community Development Block Grant (CDBG) Public Services Advisory Commission and agencies will be notified of funding decisions following City Council approval.

ATC Industries trains 'hard-to-employ' individuals and places them into living-wage jobs in the Peoria area. The program works mainly with men, age 18 and older, with life-controlling addictions, who enter the ATC Industries program through the Adult & Teen Challenge of the Greater Midwest's Pekin Men's Center. Should this grant come through, we will be able to expand the program to welcome additional 'hard-to-employ' individuals, including: - Women, age 18 and older, with life-controlling addictions - Ex-offenders - Adults with incomplete or unsuccessful work histories ATC Industries recently expanded its operations in Peoria and will be operating a facility at 8002 Sommer Street in Pioneer Industrial Park to accommodate program elements. - Assembly/Packaging for various vendors (Komatsu, Caterpillar, others) - Recycling work for Natural Fiber Welding - Fork truck training and certification for careers Program goals are: - To train 'hard-to-employ' adults in skills transferable to the workplace. - To place 'hard-to-employ' adults in full-time, living-wage employment. Order of program: - Each participant will engage in programming, either in the ATCGM program or in the Elite ReEntry program and must complete all program orientation and begin programming classes to help address their critical thinking and decision-making skills. - After four weeks of participation in either the ATCGM or the Elite Re-Entry program, the participant will be evaluated for readiness to begin training on assembly/packaging/NFW recycling work for ATC Industries. - When proficiency is achieved in training work, participant will be transitioned to various employers within

The core program of Adult & Teen Challenge of the Greater Midwest's Pekin Men's Center is evidence-based and highly successful. Since 2000, we have been operating - 24/7/365 - the 12- Month Residential Rehabilitation and Recovery program developed by Teen Challenge. Multiple\*, peer-reviewed, longitudinal, university studies confirm a more-than-75% long-term success rate, with graduates of the program remaining drug and alcohol-free, ten years postgraduation. \* Evangel University conducts a continuous longitudinal study of our program and reports of our graduates: 78% remain clean and sober, long-term. 92% report no new legal problems since graduation. 91% report improved quality relationships with family members. \* The University of Tennessee, Chattanooga, conducts a continuous, longitudinal study of the Adult & Teen Challenge program. Graduates were found to be remarkably successful in staying clean long-term: 75% of graduates were still drug-free after 12 years. 67% were abstaining from both drugs and alcohol after 12 years. Within these larger outcomes, are the following objectives in the 12-Month Residential Rehabilitation and Recovery program. 1) In the next 12 months, 25 men will enjoy 12

Explain specifically how this program addresses the priority area selected on the previous page. How does the program address the goal of violence prevention in the City of Peoria? Answer: The ATC Industries program fits into the Workforce Training priority area. Violence Prevention: For individuals struggling with addiction or the need to feed their family, the pull of violent crime can be difficult to resist. However, if a person can make a living wage and gain purposeful employment, it becomes easier for them to sustain themselves and their families, which in turn makes the pull of violent crime easier to resist. The ATC Industries program will train and place 25 'hard-to-employ' Peoria adults in living wage jobs in the next 12 months. Without such services, 'hard-to-employ' adults, like Ex-offenders, for example, may slip back into crime, even violent crime.

Since 2000, Teen Challenge Illinois has operated in the Peoria-area, helping to train and place men with life-controlling addictions into living-wage jobs. With the ATC Industries program, we are significantly expanding our workforce development.

Need: People with life-controlling addictions need to be able to support themselves once they get free from substance abuse. Often this is not easy to achieve. According to a December 16, 2018, report by National

Measurement: Each of the above objectives are SMART goals: Specific, Measurable, Attainable, Realistic and Time-Sensitive. Each can be measured chronologically and numerically. If a chronologic goal is achieved within the numerical time frame, it will be considered met. For the purposes of this grant request, we will focus specifically on Objective #8, "In the next 12 months, 25 men will receive an opportunity to work full-time in a living-wage job." ATC Industries employment-trains and places men and women from our program and the Elite Re-Entry program into living-wage jobs through our partners at Caterpillar, Morton Industries, Natural Fiber Welding, and various employers throughout the Greater Peoria community. Fortunately, even if we reach our goal of 25 men in our program placed, we still have room to place more. For this reason, we are expanding ATC Industries to employment-train and place 'hard-to-employ' adults from outside our organization, into living-wage jobs. Finally, the objectives in this request for the ATC Industries program are as follows: - In the next 12 months, 25 Peoria 'hard-to-employ' adults will be employment-trained by ATC Industries in its Pioneer Industrial Park warehouse. - In the next 12 months, 25 Peoria 'hard-to-employ' adults will be placed in full-time, living-wage jobs at either Caterpillar, Morton Industries, Natural Fiber Welding, or other employers through the ATC Industries program.



Public Radio, many people in recovery from substance abuse go long periods without work, and face stigma against hiring people with addiction history. Further, the Vertava Health of Texas' guide, Finding Employment: A Guide for Addicts in Recovery, reports: "Those who have struggled with substance abuse or addiction face barriers to employment that extend beyond the state of the job market, which level of education they've achieved, or how qualified they are, relative to the rest of the applicants. Struggles with substance abuse are rarely confined to one's personal life, for example. Oftentimes, the trials of addiction carry over into an addict's professional life as well, which leaves former users with spotty work histories and a lack of credible, positive references." Program Elements: ATC Industries trains 'hard-to-employ' adults-- mostly those with lifecontrolling addictions, for and places them in living-wage jobs in the Peoria-area. The program is headquartered at 8002 Sommer Street in Peoria. Target Population: 'Hard-to-employ' individuals. We define these as adults with life-controlling addictions, ex-offenders, and those with incomplete or unsuccessful work histories.

Our caseworkers gather data from our program participants as follows: - At enrollment - At weekly meetings with participants - At each class session - Post-program follow-up through the next 12 months (at month 6 and month 12) to track success. For the ATC Industries program and the Elite Re-Entry program, we will record attendance and participation in meetings. For specific classes covering proper use of PPE, fork truck certification, OSHA safety standards, and other workforce-related programming, as well as any other social or behavioral modification classes offered through these two programs, we will record not just attendance and participation, but proficiency. Throughout this program, our case managers will record progress toward proficiency as the participant moves from learning, to doing, to getting hired.

We have an excellent, reciprocal, working relationship with many in the nonprofit field in our area. We work extensively with Peoria Production Shop and Community Workshop and Training Center. There may be individuals being served by PPS and CWTC who could benefit from the ATC Industries program, and we will start with these sources. Additionally, we will reach out to the Salvation Army, Peoria Rescue Ministries, and the Dream Center to draw potential program participants. By working with these organizations, we believe we will have the best chance of attracting those 'hard-to-employ' individuals for which this program is designed.
