## **ORDINANCE 17,511**

AN ORDINANCE AMENDING THE CITY OF PEORIA 2017 AMENDED ANNUAL BUDGET RELATING TO THE USE OF THE WAREHOUSE DISTRICT (\$7,500), CENTRAL BUSINESS DISTRICT (\$7,500) AND DOWNTOWN CONVSERVATION TIF (\$10,000) FUND BALANCES FOR THE NATIONAL REGISTER NOMINATION PROJECT

WHEREAS, the City Council did adopt, on November 15, 2016, the 2017 Amended Annual Budget for the City of Peoria; and
