AN ORDINANCE APPROVING A SPECIAL USE IN A CLASS R-4 (SINGLE-FAMILY RESIDENTIAL) DISTRICT FOR A SHORT TERM RENTAL FOR THE PROPERTY LOCATED AT 408 N COOPER STREET (PARCEL IDENTIFICATION NO. 18-08-108-003), PEORIA, IL.

WHEREAS, the property herein described is now zoned in a Class R-4 (Single Family Residential)

District; and

WHEREAS, said Planning & Zoning Commission has been petitioned to approve a Special Use for a Short Term Rental under the provisions of Section 2.9 of Appendix A, the Unified Development Code of the City of Peoria; and

WHEREAS said Planning & Zoning Commission held a public hearing on October 7, 2021, pursuant to a notice of the time and place thereof in a newspaper of general circulation in the City of Peoria, not less than fifteen (15) days nor more than thirty (30) days prior to said hearing as required by law; and

WHEREAS, said Planning & Zoning Commission has submitted its report of said hearing and the City Council finds that to permit such special use will not adversely affect the character of the neighborhood, and will not unduly burden the public utility facilities in the neighborhood;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEORIA, ILLINOIS, AS FOLLOWS:

Section 1. That a Special Use for a Short Term Rental is hereby approved for the following described property:

Lot Eleven (11) and Five (5) feet of even width by full depth off the West side of Lot Twelve (12), all in Block Fourteen (14) in CALLENDER AND AYERS ADDITON TO THE CITY OF PEORIA, being part of the Northwest Quarter (NW ¼) of Section Eight (8) Township Eight (8) North, Range Eight (8) East of the Fourth Principal Meridian, as filed in Book "B-3" of Plats, page 217, Peoria County Records, EXCEPTING TEREFROM the South Ninety (90) feet of said Lot Eleven (11) and the West Five (5) feet of the South Ninety (90) feet of said Lot Twelve (12), situate, lying and being in the County of Peoria and State of Illinois.

Said Ordinance is hereby approved with the following conditions:

- 1. Fire extinguishers shall be installed according to the 2018 International Fire Code Chapter 9, Section 906.
- 2. Interconnected smoke detectors shall be installed according to the 2018 International Fire Code Chapter 9, Section 907.
- 3. The owner shall comply with the residential property registration code of the City of Peoria.
- 4. The owner shall obtain and maintain a valid Hotel Motel license from the City of Peoria and the owner shall pay Hotel or Motel Room Rental Use or Privilege tax to the City of Peoria.
- 5. Additional dwelling units cannot be added to the single family dwelling.
- 6. Sidewalk along the N Cooper Street frontage shall be ADA compliant.
- 7. An approved Special Use is valid for the Applicant only as identified on the special use application submitted to the Planning & Zoning Commission. An approved Special Use shall become null and void upon any change in ownership of the property which results in the removal of all prior applicants. Such change in ownership of the property will require a new special use application and approval.

Section 2. All provisions of Appendix A, the Unified Development Code of the City of Peoria, with respect to the Class R-4 (Single Family Residential) District shall remain applicable to the above-described premises, with exception to the Special Use herein permitted.

<u>Section 3.</u> This Ordinance shall be in full force and effect from and after its passage and approval according to law.
