**Proposal Bid: Facilities, Boulevard & Right of way mowing 11-22**

Date: March 14, 2022

**Previous experience:** For the last 6 years I have been mowing the Peoria Tri County Urban League. In the Spring of 2020, I began to provide mowing services for Spring Grove Subdivision. This Spring we will begin mowing services for the Peoria Community Action Agency. I run Rutherford Enterprises from my home. Rutherford Enterprises is a (1) man operation. We are a small business looking to continue/ expand mowing services in 2022 with the City of Peoria. 2014-2017 I mowed commercial and residential lawns as a subcontractor. During that time frame we mowed 60 residential properties including Chadwick, Weaver Ridge, Trails Edge & Sommer Place and maintained 200 city lots. My references include Steve Winters (309-472-6426), Sherri Cannon (309-648-3445), and Councilwoman Denise Moore.

**Approach to Project:** Currently Rutherford Enterprises equipment includes a 2008 Dodge Hemi pickup with a 2015 United 6' x 12' locked enclosed trailer. Inside we have a Toro 2017 Turbo Force Grandstand 52' commercial mower, a Exmark Lazer Z 66' commercial mower and a Echo weedwhacker and backpack blower. For trimming fence line, we have a Stihl 18" chain saw and a Stihl gas trimmer. Our capacity, looking at the South End District (1), we can mow Route 1 in 3 days. After our first mow, we will maintain/beautify Route 1 every 7-10days. We will use a (1) man crew. All litter, debris & sticks will be removed before mowing & trimming. Grass clippings will be blown off the sidewalks, back into the grass. All branches and garbage will be photographed and hauled.

**Non-Profit:** Rutherford Enterprises has provided mowing services and cleanups to 10 residential properties and one church on the South side of Peoria.

**MBE/WBE:** 100% minority owned and operated with 100% minority employees. Have all the insurances in place to satisfy the City of Peoria requirements. I look forward to getting assistance from Chris Switzer, David Watkins and Denise Moore in growing my minority business and satisfying the requirements of this contract
