RE: Temporary Liquor License Application St. Jude Riders Association Niagara Alley, 300 block Main St. (odd side alley) Class H (outdoor event)

Dear Mr. Ardis,

Enclosed is an application from the *St. Jude Riders Association* for a Class H temporary liquor license. The St. Jude Riders Association is sponsoring a St. Patrick's Day celebration which will be held on Saturday, March 17, 2018 from 9:00 a.m. to 10:00 p.m. in the Niagara Alley. This alley is located in the 300 block of Main Street (odd side alley), between the 100 block of SW Jefferson Avenue and 100 block SW Adams Street.

Officer Kevin Slavens completed a background check on Mr. Eric D. Wilson, 23245 Farmdale Rd., East Peoria, Illinois who is the club president and sole officer listed on the application. Nothing was found that would prevent him or disqualify this organization from holding the requested temporary license. Mr. Tyler Seibert will be the event chairman. Proceeds from this event will benefit the St. Jude Riders Association.

Niagara Alley will be blocked off approximately 83 feet from the 100 block of SW Jefferson Avenue to the middle of the alley. Motorists and pedestrians will be able to enter and exit Niagara Alley during this event off of the 100 block of SW Adams Street. The area for alcoholic beverage sales and consumption will be fenced and barricaded by public works, as well as staffed by five private security officers. Entry and exit into this area will be allowed at both ends of Niagara Alley and security will issue wristbands to those patrons entering the alley after being ID during this event. Mr. Seibert has applied for the appropriate permit with the city to use the alley way and will also be required to obtain an Illinois Special Event liquor license for this event.

The Peoria Police Department has no objections to this license request.
