REGULAR BUSINESS ITEMS, with Recommendations as Outlined:

**(16-049) Communication from the City Manager and Director of Public Works with a
PRESENTATION by ALTA PLANNING + DESIGN and a REQUEST to ADOPT
the PEORIA BICYCLE MASTER PLAN. (Refer to Item #14-205)**

Public Works Director Mike Rogers said Staff conducted a nationwide search to find a firm to assist with the design of a bicycle master plan for the City. He said Alta Planning + Design was selected to assist with the project. He reviewed the firm and the firm's mission, and he introduced Mr. Josh Sikich Executive Director of Alta Planning + Design.

Mr. Sikich gave a presentation of the bicycle master plan. He provided a brief overview of the planning process and the reasons to research the need for a bicycle transportation plan. He remarked that bicycling was becoming a key form of transportation. He reviewed the planning process of the bicycle master plan noting the aspects of the six E's: engineering, education, evaluation, encouragement, enforcement, equity. He reported that public engagement was encouraged through public workshops, online surveys, interactive maps and steering committee meetings. He reviewed recommendations noting it would be a plan for citizens within the City to have access to the bicycle trail within a half mile from their home.

At the conclusion of the presentation, Council Member Spain expressed his appreciation for the efforts of Alta Planning + Design in this matter. He mentioned the bicycle route near Sheridan Road and the West Bluff needed the curb cut.

Public Works Director Rogers said the plan presented would help with connectivity issues such as what was identified by Council Member Spain.

Council Member Jensen expressed appreciation for the presentation, and she asked for additional information on the efforts of obtaining public input in order to develop the plan presented.

In response to Council Member Jensen's inquiry regarding public input, Mr. Sikich said there were a number of public meetings held in the beginning to obtain information from the public. He remarked that the firm also utilized online surveys as well to obtain information.

Mayor Ardis expressed his appreciation for the presentation.

Public Works Director Mike Rogers thanked the City Council for supporting the item noting that it coincided with the City's Complete Streets Policy.

Council Member Riggerbach moved to adopt the Peoria Bicycle Master Plan; seconded by Council Member Turner.

City Manager Urich provided an overview of the item reporting that it was a request for an approval of \$145,000.00 for purchasing a house in the Center Bluff Neighborhood. He remarked that the increase in rental registration fees last fall benefited the Residential Officer Program and would assist with this purchase. He said the increased fees were placed in the Police Department budget with the anticipation of the cost of the program. He said Advanced Medical Transport owner Mr. Andrew Rand expressed a desire to support the addition of a Police Officer in the Center Bluff with a contribution towards program. He reviewed the cost of the house, closing costs and the various renovations needed prior to being habitable.

Police Chief Jerry Mitchel explained how the location of the additional Residential Police Officer was identified in the Center Bluff. He said it was their goal to identify the location that would

result with the biggest impact of having a Residential Officer. He reviewed the map outlined in the Council Communication noting that the proposed location was within two blocks of the ideal location. He said it was their goal to find a location between Knoxville and Sheridan Road. Prior to a Police Officer moving into the home, he said Staff would redo the map to get a better understanding of the crime view in that location.

Mayor Ardis expressed his appreciation towards Mr. Andrew Rand of AMT for his support of the Residential Police Officer Program. He said AMT did a lot for the community of Peoria, and he said AMT and Mr. Rand were outstanding corporate citizens. He said the Residential Police Officer Program had been successful since its implementation. He said this project would not have been accomplished without the support of Mr. Rand.

Council Member Grayeb acknowledged the efforts of Council Member Spain in bringing the Residential Police Officer Program to the community. He remarked on the City's fortuitousness in having a bilingual Police Officer in the program. He identified an important aspect of the program noting it provided the ability to address malignant properties and to abate them.

Council Member Grayeb moved to adopt an Ordinance amending the City of Peoria 2016/2017 Biennial Budget relating to the receipt of a donation from Advanced Medical Transport, in the amount of \$50,000.00, for the purchase of a Residential Officer House in the Center Bluff Neighborhood and the Transfer from the General Fund to the Capital Fund, in the amount of \$95,000.00; seconded by Council Member Ruckriegel.

Council Member Riggerbach remarked that he strongly offered his support in the project, and he thanked and extended his gratitude toward Mr. Rand and AMT.

Council Member Moore expressed her gratitude toward Mr. Rand in his support on this project. She said the Resident Officers currently in place were doing a wonderful job. She said it was her hope that others would support this program.

Council Member Montelongo expressed his gratitude toward those involved in this program. He inquired whether the City was able to track its successes since the program's implementation.

Police Chief Mitchel said the Department periodically checked the areas that had Resident Officers in them. He said they were seeing improvement with landlords in those areas and how they managed and maintained their properties. He remarked that the City could use more Resident Officers, specifically identifying the Southern Corridor and the Near North Valley. He said the Department was currently addressing those areas with additional manpower and the installation of cameras.

City Manager Urich remarked that the Resident Officer homes were the City's assets. He said it was the City's responsibility for maintaining almost all the utilities except for cable and internet. He said this program paralleled what other communities had in place. As far as taxing purposes, City Manager Urich said he would review whether the properties would be taxed and report back to the Council at a later date.

Council Member Grayeb moved to approve the purchase of the house located at 220 W. Republic Street for the Resident Officer Program at a cost of \$58,000.00 plus final closing costs and fees; seconded by Council Member Ruckriegel.

(16-051) Communication from the City Manager with a Request to ADOPT an ORDINANCE Approving the GRANDVIEW LODGING, INC. REDEVELOPMENT AGREEMENT. (1st District)

Assistant City Manager Chris Setti provided an overview on the proposed Redevelopment Agreement with Grandview Lodging, Inc. He said the company planned to renovate the property and open the doors for business within the next 12 – 18 months. He reported that the hotel anticipated hiring 75 people with an annual payroll of approximately \$1.5 million. He said this development was very important to the economy of the downtown.

Council Member Moore remarked on the importance of the redevelopment and the impact it would have on the downtown area, accompanied with additional conventions and conferences.

Council Member Spain expressed his appreciation for Staff's efforts in this matter, and he remarked on the importance of having an additional downtown hotel to support the activities of the Civic Center. He said the City would look forward to having this hotel back up and running and looked forward to the positive impact it would have on the downtown area.

Council Member Moore moved to adopt an Ordinance approving the Grandview Lodging, Inc. Redevelopment Agreement; seconded by Council Member Turner.

Council Member Moore announced that the first landlord training was held this evening. She inquired whether the landlords were aware of the changes, and she expressed a concern for landlords who were doing the right thing, but were being penalized.

Council Member Moore moved to adopt an Ordinance amending Chapter 13 of the Code of the City of Peoria pertaining to Environmental Violation Fines and Administrative Fee for Work Orders; seconded by Council Member Riggerbach.

Council Member Moore moved to adopt an Ordinance amending Chapter 5 of the Code of the City of Peoria pertaining to criminal housing management; seconded by Council Member Turner.

ORDINANCE NO. 17,327 was adopted by roll call vote.

Council Member Moore moved to adopt an Ordinance amending Chapter 32 of the Code of the City of Peoria pertaining to Criminal Housing Management; seconded by Council Member Riggerbach.

Council Member Jensen expressed a concern about adding criminal housing management to enforcement through administrative adjudication. She said criminal housing management was a serious enough offense that it should be enforced through the court system. She said the current language proposed would bind the City to pursue criminal housing management charges enforcement through administrative adjudication. She said by adopting this Ordinance, it would allow for all criminal housing management charges and violations to be taken to the administrative Hearing Officer instead of providing the flexibility of taking those violators to court when serious. She said she would be opposing this item, stating that criminal housing management was such a serious offense it should be taken to court rather than to the Administrative Hearing Officer.

Corporation Counsel Don Leist said that State Statute would allow the City to bring an appropriate action to the Circuit Court should circumstances warrant it. He said it would tend to place most complaints before the Hearing Officer, but he said the more egregious situations could be brought to the Circuit Court. He said there still would be flexibility to file a case in the Circuit Court.

Discussions were held as to how a matter would be filed in the Circuit Court.

Council Member Moore remarked that this would not preclude the City from taking additional action.

Council Member Moore expressed a concern for overburdening the Hearing Officer, and Corporation Counsel Leist said it was the City's discretion as to what cases to bring before the Hearing Officer. He said that situation would be monitored in order to prevent the Hearing Officer from being overburdened. If necessary, he said the City would take some of those cases and file them in the Circuit Court.

Council Member Moore expressed her appreciation to the Hearing Officer and his efforts in these matters.

Council Member Grayeb reviewed the reason why the City utilized a Hearing Officer versus taking these matters to Circuit Court. He said the previous City Council wanted to streamline the process and have an even application of the City's rules.

Council Member Moore moved to adopt an Ordinance amending Chapter 32 of the Code of the City of Peoria pertaining to Criminal Housing Management; seconded by Council Member Riggerbach.

NEW BUSINESS

Two Men Who Made a Difference in Peoria: Les Kenyon & George Kottemann

Council Member Ruckriegel announced that the Peoria Public Library would be having an exhibit from February 1, 2016, through February 28, 2016, of Kenyon & Kottemann. He asked for Privilege of the Floor to the ArtsPartners of Central Illinois Curator, Mr. Bennett Johnson, to provide additional information.

Hearing no objection, Mayor Ardis granted Privilege of the Floor to Mr. Bennett Johnson.

Mr. Johnson provided additional information regarding the Kenyon & Kottemann exhibit that would be on display at the Peoria Library through the month of February. He said the exhibit would be free. He remarked that Kenyon was a well-known architect with a prolific career in Peoria, noting he was well known for preservation of the historic buildings.

Black History Month

Council Member Moore announced that February was Black History Month. She remarked that it was an important part of American History, and she encouraged everyone to check social media events.

“Ain’t I a Woman” – Methodist College

Council Member Moore announced that “Ain’t I a Woman” would be performed at Methodist College on Wednesday, February 10, 2016 at 6:30 P.M. at 4015 St. Marten Court. She encouraged everyone to attend.

Rental Registration Fees

Council Member Riggerbach reminded everyone that the increase in rental registration fees assisted the City in supporting and serving the neighborhoods.

Walkways/Sidewalks Across Knoxville Avenue

Council Member Johnson remarked on a tragic accident that occurred on January 27, 2016, on North Knoxville Avenue wherein a pedestrian was struck by a vehicle. He remarked that connectivity had been very important to the Council, and several requests had been placed with IDOT for sidewalks across North Knoxville. He said he would like a meeting with IDOT as soon as possible to discuss the matter.

Mayor Ardis requested that the correspondence the City had IDOT regarding the situation with War Memorial Drive also be included. He said IDOT acknowledged the situations, but they did not have the money to provide safe access.

CITIZENS' OPPORTUNITY TO ADDRESS THE CITY COUNCIL/TOWN BOARD

Hearing no objection, Mayor Ardis granted Privilege of the Floor to those citizens wishing to address the City Council/Town Board.

Ms. Lavetta Ricca, a citizen of Peoria, expressed a concern for the neighborhoods, and she read an article by Community Development Director Ross Black that was published in the Peoria Journal Star, pertaining to Code Enforcement.

Mr. Marcus Fogliano, a citizen of Peoria, asked that the Council review the City's water, noting that issues that occurred in Flint, Michigan. He asked the Council to advocate with State Legislators for lead abatement funding. He expressed appreciation for the approval of the new Resident Officer Home. He remarked on the number young youth leaders in the community and the need to enhance those leaders.

Mr. Amo EISamny, a citizen of Peoria, remarked on the need for peace and less division between cultures. He said the City of Peoria needed a resolution to address the division in society, and he said the City of Normal had such a resolution.

Mayor Ardis asked the City's Communications Director to promote "Fight Hate with Community Dialogue" on March 7, 2016, from 6:00 to 8:00 P.M. at the Islamic Foundation of Peoria.

EXECUTIVE SESSION
