Hearing no more comments or questions, Chairman Miller called for the motion.

Commissioner Coates moved to recommend approval of the Site Application for a Class B-1 (restaurant, 25% food) Liquor License, with a Subclass 3 (beer garden) at 5901 N. Prospect, Suite 7; seconded by Commissioner Kouri.






