ORDINANCE 17,508

AN ORDINANCE AMENDING THE CITY OF PEORIA 2017 AMENDED ANNUAL BUDGET RELATING TO THE CAPITAL FUND TO RECOGNIZE THE RECEIPT OF A FEDERAL GRANT FROM THE BUREAU OF JUSTICE ASSISTANCE (BJA) OF THE DEPARTMENT OF JUSTICE (DOJ) UNDER THE TECHNOLOGY INNOVATION PUBLIC SAFETY GRANT AND THE CORRESPONDING EXPENDITURES IN THE AMOUNT OF \$165,000.
