





A site application has been received from *SRC Group, LLC*, d/b/a Scottish Rite Theater, 400 NE Perry Ave., Peoria, Illinois for a Class K and Subclass 2 liquor license. Approval of this application would allow the applicant to operate a rental hall and host live entertainment at this location. A Class K liquor license also allows the applicant to cater off site.
