



HOME SECURITY CAMERA REGISTRATION PROGRAM

INTRODUCTION:

The City of Peoria Police Department invites you to register your external (or doorstep-facing) home security camera. The public's participation in the voluntary Home Security Camera Registration Program helps the police department deter and decrease crime. This "neighborhood watch of the 21st century" will potentially provide video evidence to get criminals off the streets.

The City of Peoria Police Department will not have the ability to freely access your cameras, claim ownership, or dictate the camera system's function. The registration program provides your contact information with the City of Peoria Police Department. This is simply a contact list that will allow the City of Peoria Police Department to see who might have captured security footage that may be related to a crime that occurred in your area. This process aids and enhances the investigation and may lead to the quick apprehension of the criminal.

Registering your security camera shows your willingness to deter, fight, and solve crime. This police-citizen bond helps keep Peoria safe. Registration is entirely voluntary.

CAMERA SUBSIDY:

The City Council has set aside funds to aid Peoria residents in purchasing a home security camera. Cameras purchased, installed and registered with the Police Department would be eligible for \$50.00 to help off-set the cost of the security system purchase.

TERMS OF USE/POLICY:

The information provided about you and your camera system will be for official use only. Your personal information will remain confidential and will not be distributed except as required by law or court order. If necessary, the City of Peoria Police Department may contact you directly, utilizing the information provided by you at time of registration, to request the appropriate video surveillance footage. Any footage containing or related to criminal activity collected by the Peoria Police Department may be utilized as evidence during any stage of a criminal proceeding. Under no circumstance shall the registrants construe that they are acting as an agent and/or employee of the City of Peoria and/or the City of Peoria Police Department through this program. The Peoria Police Department will not request or obtain direct access or remote access to the camera equipment, security footage, or cloud-stored data.

REQUIREMENTS FOR SUBSIDY PROGRAM:

- Applicants must be an owner or tenant of a property that is used as a residence located in the City of Peoria.
- Applicants who are tenants must provide documentation from the property owner approving the installation of the security camera system on the property.
- The camera system must have been purchased and installed on the property after March 1, 2020 and before all available funds are expended.
- The camera system must be registered with the City of Peoria Police Department.
- Security camera systems must be installed on the exterior of a building.
- Purchase of cameras must be verified by a valid receipt.
- Installation of cameras will be verified.
- All cameras must be outdoor, weather-proof cameras. We strongly recommend purchasing a camera that is designed for the outdoors as opposed to modifying one designed for indoor use.
- Only one security camera system per property address is eligible.
