AN ORDINANCE AMENDING THE CITY OF PEORIA 2017 AMENDED ANNUAL BUDGET RELATING TO THE GENERAL FUND TO RECOGNIZE THE RECEIPT OF A GRANT FROM THE ILLINOIS DEPARTMENT OF REVENUE FOR THE TOBACCO ENFORCEMENT GRANT, IN THE AMOUNT OF \$10,450.00; THE RECEIPT OF A GRANT FROM THE ILLINOIS CRIMINAL JUSTICE AUTHORITY DOMESTIC VIOLENCE MULTI-DISCIPLINARY TEAM RESPONSE PROGRAM IN THE AMOUNT OF \$88,648; THE RECEIPT OF A GRANT FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION SUSTAINED TRAFFIC ENFORCMENT PROGRAM (STEP) GRANT IN THE AMOUNT OF \$23,296; THE TRANSFER FROM THE GENERAL FUND (POLICE OPERATING BUDGET) TO CAPITAL FUND IN THE AMOUNT OF \$16,000 TO PURCHASE A NEW SERVER FOR CITY WIDE POLICE CAMERAS AND THE RECEIPT OF GRANTS FROM ENBRIDGE IN THE AMOUNT OF \$1,000; ILLINOIS AMERICAN WATER IN THE AMOUNT \$1,000 AND VERNON "BUTCH' CHARITABLE FUND IN THE AMOUNT OF \$750.
