AN ORDINANCE AMENDING CITY OF PEORIA 2021 REVISED ANNUAL BUDGET RELATING TO THE STORMWATER UTILITY ENTERPRISE FUND TO PROVIDE ADDITIONAL FUNDING FOR THE GLEN AND SHERIDAN ROAD CULVERT PROJECT IN THE AMOUNT OF \$60,796.80 AND RECOGNIZE THE RECEIPT OF THE PROPERTY OWNER'S SHARE IN THE AMOUNT OF \$34,259.16.

WHEREAS, the City Council did adopt, on November 11, 2020, the 2021 Revised Annual Budget for the City of Peoria; and
