Project Amendment No. Seven

THIS AMENDMENT to Project Agreement No. 17-00769.7 is hereby made and agreed upon by the United States of America, acting through the Director of the National Park Service and by the State of Illinois pursuant to the Land and Water Conservation Fund Act of 1965, 78 Stat. 897 (1964).

The State and the United States, in mutual consideration of the promises made herein and in the agreement of which this is an amendment, do promise as follows:

That the above mentioned agreement is amended by adding the following:

- Add a co-sponsor of Peoria Park District. IDNR received a letter and the agreement July 10, 2014 after amendment 3 was done, IDNR didn't follow up with NPS to add this to the records for this grant. Peoria Park District will only affect the Rocky Glen Property. Peoria Park District now owns Rocky Glen Property and acknowledges and understands the LWCF program regulatory responsibilities associated with acquiring and developing land with LWCF grant assistance.
- The 6(f) boundary will be amended by deleting 3.345 acres of property from the RiverPlex located at 600 Northeast Water Street, Peoria, IL. Parcel# 18-10-151-003
- The replacement property listed below will also be shown on the new 6(f) boundary map.
 - Rocky Glen 207 N Kickapoo Creek Rd., West Peoria, IL Parcel# 17-12-100-018
 - City of Peoria owned Parcel "L" shaped land to make the park contiguous Parcel# 18-03-451-002
 - Simantel property located at 1 Spring St. Peoria, IL. Parcel# 18-03-451-003

In all other respects the agreement of which this is an amendment, and the plans and specifications relevant thereto, shall remain in full force and effect. In witness thereof the parties hereto have executed this amendment as of the date entered below.
