





Dear Commissioners:

Building and Zoning staff from the Community Development Department have reviewed the above listed request. The following is a summary of the results:

- 1. The property is currently zoned C2 (Large-Scale Commercial) District. Restaurant with outdoor restaurant area (sidewalk café) is a permitted use.
- 2. The existing commercial building consist of two tenant spaces. The proposed tenant space is currently vacant and does not have an outdoor seating area.
- 3. The applicant must first submit plans prepared and stamped by a design professional to obtain a building permit for the proposed use, including the outdoor seating area.
- 4. The outdoor seating area is considered an expansion to the building and must maintain the minimum 10'3" setback (5% of of the lot width) from the property line. A scaled site plan is needed to determine if the required setback can be met for the outdoor seating area.
- 5. All necessary building and trades permits must be obtained prior to work commencing.
- 6. Mechanical, electrical and plumbing work must be accomplished by licensed and registered contractors in the City of Peoria. All work shall adhere to 2018 International Code series, 2018 IECC, 2017 NEC, 2018 Illinois Plumbing Code, and 2018 Illinois Accessibility Code.
- Work must be completed as illustrated in the approved plans and the Certificate of Occupancy must be obtained prior to operation.

The Community Development Department does not object to the requested liquor license upon issuance of a Certificate of Occupancy/Complettion for any construction work.
