Enclosed is an application from the Neighborhood House Association for a Class H temporary liquor license to be used on Saturday, May 21, 2016, from 9:00 a.m. until 11:00 a.m. at Sprinkmann Insulation, 1028 SW Washington St. The Neighborhood House is hosting the second annual George Jacob "Gut Buster" 5K race and this site will be one of six locations along the race route in which participants may consume alcoholic beverages. These locations will also provide non-alcoholic drinks. There will also be five different food locations along the race route as well. As part of the race, participants may partake in a contest in which they have a card punched after visiting each location. There is no requirement to consume alcoholic beverages as part of the contest. This license will allow the service and consumption of alcoholic beverages during the race at this location. Security will be provided by on duty Peoria Police Officers, employees of the Neighborhood House and other volunteers.

Officer Kevin Slavens completed a background check on the listed officers of this organization. Ms. Rebecca Rossman, 2268 Partridge Ln., Washington, Illinois is the president of the association and Ms. Amy Jansen, 494 Knox Rd., P.O. Box 244, Yates City, Illinois, is the secretary. Mr. Tom Wiegand, 214 Cypress Point, Washington, Illinois, is the event chairman. Nothing was found that would prohibit the approval of this application.

The Peoria Police Department has no objections to this temporary license request.


