He said once the project was completed, then the property would be sold. He said the cost of the property would be offset by the money allotted for erecting or renting a field office. He said a similar situation occurred at the Allen-Alta Roundabout wherein the City purchased a property at that location, which was used as a field office until that project was completed.

She said the commission was comprised of new and returning volunteers. She announced the Great American cleanup was scheduled for April 29, 2017. She said the Commission would meet every Monday at City Hall at noon. She said Terence Acquah from the Community Development Department would be working with the different neighborhood organizations to help do their part with litter pick-up.

She said the girls who attended were greatly inspired by the movie, and she said three of those girls were present to express their appreciation to the City Council for their support. Mr. General Parker, a concerned citizen, requested another bus stop to be placed on University Street North of the Post Office. He commented that he had received complaints about the design of MacArthur Highway noting the lanes had been reduced to one lane each way. He said the Black Star Project was sponsoring a Red, Black, Clean and Green Day wherein they would sponsor the clean-up of streets, alleys and lots within the City. He said he would like to work with the City in order to promote the clean-up day.
