Jared Ford, Acting General Manager, presented a Site Application for a Class B (restaurant, 50% food) Liquor License, with a Subclass 3A (sidewalk café) at 1108 W. Glen.

In discussion with Chairman O'Brien, Mr. Ford briefly described the location, and he said the plan was to have a healthier choice quick dining experience. He reported there would be a small market where patrons could explore a number of different options that were not offered in the Peoria area, including gluten free meals. He explained there would also be a meeting space and an outdoor patio. He then reported there would be a mini bar with wine and crafted beers. He said initially, the ratio would be 20% alcohol vs. 80% food.

In response to a question from Commissioner Spears regarding outdoor seating, Mr. Ford referred to the submitted drawing. He said there would be approximately 8 to 9 four top tables outside. He confirmed there might be light acoustic music out in the patio on special occasions, but he said there was no plan for outdoor music concerts or anything like that.

In discussion with Commissioner Coates regarding their hours of operation, Mr. Ford said their business hours would be from 11 am to 8 pm on Sunday thru Thursday and from 11 am to 9 pm on Friday and Saturday, seven days per week.

Hearing no more comments or questions, Chairman O'Brien called for the motion.

Commissioner Winkler moved to <u>approve</u> the Site Application for a Class B (restaurant, 50% food) Liquor License, with a Subclass 3A (sidewalk café) at 1108 W. Glen; seconded by Commissioner Spears.




