RESOLUTION approving sites located in the City of Peoria, Peoria County, Illinois, to be acquired, altered and improved by the Public Building Commission of Peoria, Peoria County, Illinois, and leased by said Commission to the Board of Education of the City of Peoria, School District Number 150, Peoria County, Illinois.

WHEREAS, the Public Building Commission of Peoria, Peoria County, Illinois (the "Commission"), a municipal corporation heretofore duly organized under the provisions of the Public Building Commission Act of the State of Illinois, as amended (the "Act"), was incorporated for the purpose of constructing, acquiring, enlarging, improving, repairing or replacing public improvements, buildings or facilities for government, and related services and facilities; and

WHEREAS, the Commission has heretofore selected sites lying wholly within the territorial limits of the City of Peoria, Peoria County, Illinois (the "City"), as sites to be acquired by the Commission (the "Sites"); and

WHEREAS, the Sites will be altered and improved by the Commission (the "*Projects*") and will be leased by the Commission to the Board of Education of the City of Peoria, School District Number 150, Peoria County, Illinois, in accordance with the terms of the Act; and

WHEREAS, the Sites are more particularly described in *Exhibit A* attached hereto and made a part hereof; and

WHEREAS, pursuant to Section 14 of the Act, the areas selected by the Commission as the sites to be acquired by the Commission for the construction, alteration or improvement of buildings for the purposes set forth in said Section of the Act, are subject to approval by a majority of the members of the governing body of the municipality where the sites are located; and

WHEREAS, it is necessary and in the best interests of the City that the Sites be approved by the City Council of the City (the "City Council") pursuant to said Section 14 of the Act:

Now, Therefore, Be It and It is Hereby Resolved by the City Council of the City of Peoria, Peoria County, Illinois, as follows:

Section 1. Incorporation of Preambles. The City Council hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Approval of Sites. Pursuant to Section 14 of the Act, the City Council hereby approves the selection by the Commission of the Sites as the locations to be acquired by the Commission for the Projects.

Section 3. Severability. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

Section 4. Repealer and Effective Date. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed and this Resolution shall be in full force and effect forthwith upon its adoption.
